THE COUNCIL OF THE METROPOLITAN SERVICE DISTRICT HEREBY ORDAINS:

Section 1. The Metro Council finds that there is a need to provide for a clear enforcement mechanism of present provisions of the Metro Code prohibiting illegal parking in the Zoo parking lot and other areas adjacent to the Washington Park Zoo in order to protect the public health and safety and that such prohibition should include the mechanism of enforcement of such an ordinance by authorizing Metro personnel to issue standard form parking citations utilized by the Multnomah County District Court in a manner consistent with state law and that Metro has the authority to adopt such provisions and provide for such enforcement pursuant to ORS chapter 268.

NOW, THEREFORE, Chapter 4.01 Zoo Regulations is amended to read as follows:

Section 4.01.030 Parking Lot and Sidewalk Adjacent to the Zoo is amended to read:

(a) Vehicular and Pedestrian Traffic:

(1) It shall be a violation of this Code for the driver of any motor vehicle or bus to violate any legend or direction contained on any sign, signal or marking now installed or hereafter installed upon any street, avenue, parking lot or other public way within the boundaries of the Washington Park Zoo or the surrounding area leased by the City of Portland to Metro for public access or for public parking at the Zoo. Drivers of all vehicles shall drive in a careful and safe manner at all times and shall comply with the signals and directions of the police or security officers and all posted traffic signs.

(2) Blocking of entrances, driveways, walks, loading platforms, or fire hydrants is prohibited. Parking without authority, or parking in unauthorized locations or in locations reserved for other persons or contrary to the directions of posted signs, is prohibited.

(b) [Advertising, Canvassing, Soliciting and Disseminating of Written Materials for Political, Charitable or Religious Purposes. Advertising, canvassing, soliciting and disseminating of written materials for political, charitable, or religious purposes is permitted on the parking lot and sidewalks between the parking lot and the perimeter fence surrounding the Zoo. Such activities must be conducted in accordance with the following conditions:

[(1) Parking lot entrances, exists and travel lanes must not be obstructed. Interference with traffic flow is prohibited.

[(2) Loudspeakers and other sound devices are prohibited.

[(3) Activity causing a crowd to gather is prohibited if pedestrian or vehicular traffic is obstructed or impeded.

[(4) Activity conducted within twenty (20) feet of an admission gate, ticket booth, entrance or exit is prohibited.

[(5) Activity shall be conducted by no more than two (2) persons in the vicinity of the entrances or exists for each cause or candidate.

[(6) Obstructing Zoo visitors' line of travel or detaining a Zoo visitor or employee against his or her will is prohibited.

[(7) Abusive language and actual or threatened physical harm directed against a Zoo visitor or employee is prohibited.

[(8) A person conducting such activity shall identify his or her cause or candidate and shall not misrepresent his or huer purpose.

[(9) The dissemination of food or goods other than written materials is prohibited.]

Security personnel designated by the Executive Officer of Metro as serving as a Zoo Parking Patrol shall have the authority and duty to issue parking citations in accordance with subsection (c) of this section for a violation specified by subsection (a) of this section. The Zoo parking patrol shall have no other police authority or duty. Persons appointed as Zoo parking patrol shall be special police officers of the Metropolitan Service District. As special police officers the Zoo parking patrol personnel and the Zoo parking patrol supervisor shall have authority to issue citations for violations of parking or non-moving traffic violations occurring on Zoo property or property adjacent to the Zoo leased from the City of Portland by the Metropolitan Service District for Zoo parking purposes, and particularly they shall have authority to issue citations as provided for in Section 4.01.030 of the Metro Code. To the

extent of the power and authority granted in this section, such personnel and their supervisor shall exercise full police power and authority.

(c) Parking Citations:

(1) Form of citations. All parking citations forms used by the Zoo parking patrol shall be in a form approved by the General Counsel of Metro and as issued by the District Court for the State of Oregon for Multnomah County. Such parking citations shall, at a minimum, clearly state:

- (A) the date, place and nature of the charge;
- (B) time and place for the defendant's appearance in court;
- (C) name of the issuing officer;
- (D) license number of the vehicle.

(2) Procedure for issuing citations. Any citation form issued pursuant to this Code section shall either be delivered to the defendant or placed in a conspicuous place upon the vehicle involved in the violation. A duplicate original of the notice shall serve as the complaint in the case when it is filed with the court. In all other aspects, the procedure now provided by law in such cases shall be followed, but ORS 810.365 does not apply. The officer need not have observed the act of parking, but need only observe that the car was parked in violation of the Metro Code.

(3) Use of parking citation as a complaint. The original of the traffic citation form when completed to meet the minimum requirements of ORS 221.340 may serve a complaint, other forms of parking complaints are prohibited.

(4) Citation form books issued by District Court. Citation form books for parking violations shall be provided by the District Court and upon request distributed to the Zoo parking patrol officers who issue them.

(5) List of parking citations. A list of the parking citations issued by Zoo parking patrol officers shall be forwarded to the District Court within twenty-four (24) hours.

(d) Person Responsible for Violation Charged by the Citation. The registered owner of the vehicle is prima facie responsible for the violation charged by the citation.

(e) Advertising, Canvassing, Soliciting and Disseminating of Written Materials for Political, Charitable or Religious Purposes.

Advertising, canvassing, soliciting and disseminating of written materials for political, charitable, or religious purposes is permitted on the parking lot and sidewalks between the parking lot and the perimeter fence surrounding the Zoo. Such activities must be conducted in accordance with the following conditions:

- (1) Parking lot entrances, exits and travel lanes must not be obstructed. Interference with traffic flow is prohibited.
- (2) Loudspeakers and other sound devices are prohibited.
- (3) Activity causing a crowd to gather is prohibited if pedestrian or vehicular traffic is obstructed or impeded.
- (4) Activity conducted within twenty (20) feet of an admission gate, ticket booth, entrance or exit is prohibited.
- (5) Activity shall be conducted by no more than two (2) persons in the vicinity of the entrances or exists for each cause or candidate.

STAFF REPORT

CONSIDERATION OF ORDINANCE NO. 88-251, FOR THE PURPOSE OF AMENDING SECTION 4.01.030 OF THE METRO CODE TO PROHIBIT ILLEGAL PARKING IN THE ZOO PARKING LOT AND OTHER AREAS ADJACENT TO THE WASHINGTON PARK ZOO, AND PROVIDING FOR THE ISSUANCE OF CITATIONS BY METRO PERSONNEL

FACTUAL BACKGROUND AND ANALYSIS

Concerts at the Zoo on Wednesday and Thursday evenings during the summer have increased in popularity over the past several years. Despite the provision of shuttle bus services to and from the public parking lot and the Sylvan Business Complex, some motorists park their vehicles in restricted areas, e.g., sidewalks, driveways and fire lanes. This has impeded pedestrian and traffic flow as well as created hazards in emergency situations. Similar conditions exist on weekends, holidays and during other special events.

Citation authority provided to security officers assigned to parking lot patrol would be the most effective method for security personnel to ensure a more safe and hazard-free environment. It is therefore recommended that personnel as provided be authorized to issue standard form parking citations utilized by the Multnomah County District Court in a manner consistent with State law.

EXECUTIVE OFFICER'S RECOMMENDATION

The Executive Officer recommends adoption of Ordinance No. 88-251.

ZOO AND AUTHORIZES ISSUANCE OF CITATIONS BY METRO
PERSONNEL

Ordinance No. 88-251 was introduced by the Executive Officer to enable Zoo personnel to control illegal parking in the Zoo parking lot. The ordinance was considered by the Committee at its June 21, 1988, meeting. Councilors attending the meeting were DeJardin, Collier, Kelley and Kirkpatrick. Councilor Waker was excused. The Committee unanimously approved a motion that the Council adopt Ordinance No. 88-251 as amended.

Ordinance No. 88-251 amends Chapter 4.01 of the Metro Code (Chapter 4.01 sets regulations for the operation of the Zoo): The ordinance does the following:

1. Adds language in Section 4.01.030(a) establishing what a parking violation is and where enforcement shall take place (see attached map for an illustration of the enforcement area).
2. Deletes (b) of Section 4.01.030 and reinserts it as subsection (e) of the same section.
3. Adds new language in subsection (b) which authorizes security personnel to issue parking citations and limits the authority of security personnel to enforcement of only parking regulations (no other police power or authority is granted).
4. Adds language in subsection (c) which specifies the form of the citations and the procedures and requirements for issuance.
5. Adds language in subsection (d) which places the responsibility for citations with registered owner of the vehicle.

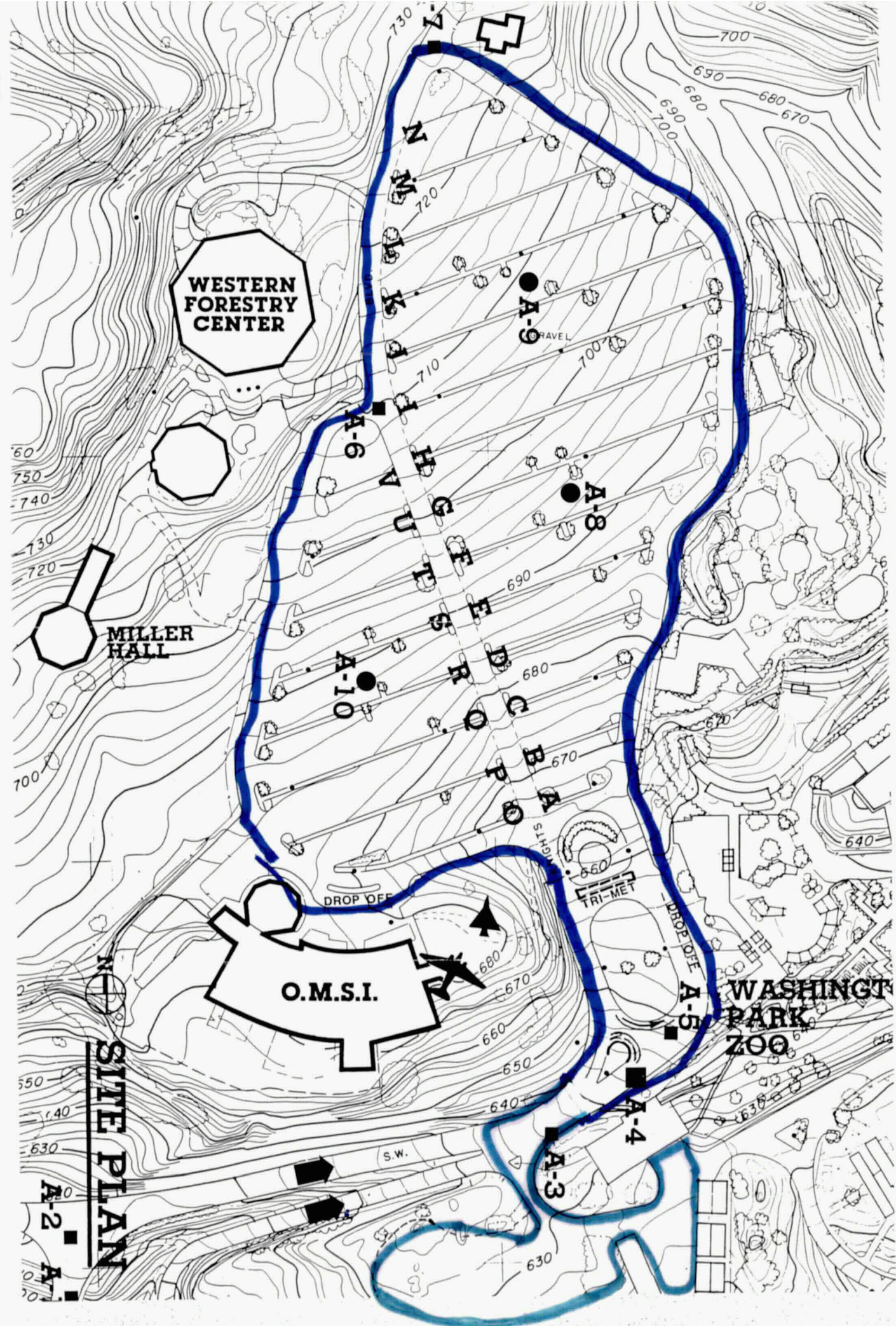

The issues raised by the Committee in discussing this proposed ordinance were: 1) how much police power and authority is being granted and 2) the projections of revenue from the parking citations. The Committee was assured that the police power granted was limited to only issuance of parking citations resulting from parking violations and asked Zoo staff to monitor the revenue raised from this activity and report back to the Committee after a reasonable period of time.

The Committee amended the proposed ordinance for purposes of clarification by inserting the words "or sale" after the word "dissemination" in subsection (9) of subsection (e) on page 4 of the ordinance.

one percent of the solid waste operating budget or approximately \$300,000 for FY 1988-89. Councilor Hansen noted the Council had already approved the project budget.

Councilor Gardner said he supported the program and hoped the funded projects would be innovative. He also hoped the program focused solely on recycling and not small alternative technology projects.

The Presiding Officer noted one of the program requirements was an annual report to the Council from the project committee. He requested the Executive Officer develop guidelines for the reporting process and distribute those guidelines to the Council.

Vote: A roll call vote on the motion to adopt the ordinance resulted in all nine Councilors present voting aye. Councilors Collier, Cooper and Waker were absent.

The motion carried and the ordinance was adopted.

7.4 Ordinance No. 88-251, for the Purpose of Amending Section 4.01.030 of the Metro Code to Prohibit Illegal Parking in the Zoo Parking Lot and Other Areas Adjacent to the Washington Park Zoo, and Providing for the Issuance of Citations by Metro Personnel

The Clerk read the ordinance a second time by title only. Presiding Officer Ragsdale announced the first reading of the ordinance was conducted before the Council on June 9 and it was then referred to the Intergovernmental Relations Committee for a public hearing and recommendation. The Committee considered the matter on June 21.

Councilor DeJardin, Vice-Chair of the Intergovernmental Relations Committee, reported the ordinance was drafted after regretful circumstances brought about by Zoo visitors parking in fire lanes and other prohibited areas on concert nights and other busy periods. The ordinance was necessary to discourage people from continuing illegal parking practices. The Committee had unanimously recommended adoption of the ordinance.

Motion: Councilor DeJardin moved, seconded by Councilor Kelley, to adopt Ordinance No. 88-251 as recommended by the Intergovernmental Relations Committee.

Responding to Councilor Knoles' questions, Zoo Security Manager Dick Karnuth explained that under current provisions, Zoo personnel could have cars towed only after City of Portland police issued traffic violations. Due to heavy traffic on concert nights, that was not a workable solution. The ordinance would allow Zoo personnel to issue citations.

Councilor Coleman asked how the amount of citations would be determined. She was thought the amount should be high enough to deter continued parking violations. Dan Cooper, General Counsel, explained he would soon draft an ordinance providing for the citation amount to be determined by the Multnomah County Court. Citations would then be the same as those issued by Portland and County police, he said. Amounts would vary depending on whether the violator had parked in a handicapped parking zone, a fire lane, etc. He pointed out the Metro Code provided a maximum penalty of \$500 for violating any Code provision.

Councilor Van Bergen was concerned about prohibited activities listed in Section 4.01.030(3)(1) through (9). He suggested staff work with the Multnomah County Bar Association to have those provisions reviewed and an opinion rendered. He was concerned about possible exposure if someone sued for false arrest or if Zoo security staff carried weapons or were not adequately trained. He also suggested staff talk with Tri-Met to learn from its police program experience. Councilor Kelley said she shared some of the Councilor's concerns. She thought the Council should review the new citation program in September to see if improvements should be made.

Councilor Hansen said he hoped staff would mark parking areas in order to warn Zoo visitors that citations would be issued to violators.

Vote: A roll call vote on the motion to adopt the ordinance resulted in all nine Councilors present voting aye. Councilors Collier, Cooper and Waker were absent.

The motion carried and the ordinance was adopted.

Councilor DeJardin said he had noticed solicitors near the Zoo's entrance and suggested a sign be posted informing the public that people had the right to solicit at that location but those people did not necessarily reflect the views and opinions of Metro. Presiding Officer Ragsdale said the Executive Officer could direct staff to post such a sign.

9. COMMITTEE REPORTS

Solid Waste Committee. In response to Councilor Knowles' question, Councilor Hansen reported the Committee would soon forward legislation to the Council regarding policy for the East Transfer & Recycling Center(s). The Council could expect to consider the legislation in August, he said. Councilor Knowles was concerned that further delays in developing policy would narrow the field of firms responding to a bid for transfer station services.

5.2 Consideration of Resolution No. 88-922, for the Purpose of Revising Guidelines for the Expenditure of Council Per Diem, Councilor Expense and General Council Materials and Services Accounts

Motion: Councilor Van Bergen moved to adopt the resolution and Councilor Knowles seconded the motion.

Vote: A vote on the motion resulted in all eleven Councilors voting aye.

The motion carried and Resolution No. 88-922 was adopted.
