Committee Recommendation: At its August 9, 2000, meeting, the Operations Committee voted 3-0 to recommend Council adoption of Resolution No. 00-2979. Voting in favor: Atherton, Monroe, Washington. Voting against: None. Absent: None.

**Background:** Charles Ciecko, Regional Parks and Greenspaces Director, presented the staff report. He explained that the Regional Parks and Greenspaces Advisory Committee, previously established by resolution, has 11 appointed members: one from each Metro Council district, and one representative from each area outside Metro boundaries within Clackamas, Multnomah, Washington, and Clark counties.

Two positions are currently vacant as a result of term expiration and two-year term limits: one from Council District One and one from Council District Three. Applications for the vacant positions were solicited from citizens through a public process, and Rod Peters applied to serve on the committee as a representative from Council District Three. The Executive officer, after review of Mr. Peter's application, is nominating him to serve on the Committee.

Committee Issues/Discussion: Councilor Atherton asked whether Councilor Kvistad also endorsed this position, since it is representing his district. Staff has checked with Councilor Kvistad and he has no objections to the appointment.

### **BRIEF DESCRIPTION OF RESOLUTION**

This resolution intends to appoint a citizen from Metro Council District #3 to the Metro Regional Parks and Greenspaces Advisory Committee.

### **EXISTING LAW**

On October 13, 1994 Metro Council adopted Resolution 94-2026A to establish the Regional Parks and Greenspaces Advisory Committee. The purpose of the committee is to review, comment, and make recommendations related to policies, plans, programs, user fee structure, annual budget plans and similar issues facing the Metro Regional Parks and Greenspaces department. The committee serves an advisory role to Metro Council, Executive Officer and the Metro Regional Parks and Greenspaces Department. Committee members serve a 3-year term.

### **BACKGROUND**

The advisory committee has 11 positions: one representative from each Metro Council district; one representative from Clackamas, Multnomah and Washington counties outside Metro boundaries; and one representative from Clark County. Attachment 1 lists current members serving on the Regional Parks and Greenspaces Advisory Committee. Committee positions currently vacant and subject to Metro Council confirmation include Metro Council districts #1 (Councilor Park) and #3 (Councilor Kvistad). The vacancies occurred March 31, 2000 as a result of term expiration and limitation (2 term limit).

Citizen applications were solicited through announcements at public meetings, to the Metro Committee for Citizen Involvement and Metro Regional Parks and Greenspaces Advisory Committee and communications to the Metro Executive Office and Metro Councilors representing Districts #1 and #3. One candidate from District #3 (Rod Peters) applied to serve on the committee.

The Executive Officer nominates Rod Peters (Council District #3) for Metro Council consideration (Exhibit A) after a review of his application to serve on the committee.
