ORDINANCE NO. 49

THE METROPOLITAN SERVICE DISTRICT ORDAINS THE FOLLOWING:

SECTION 1. Definitions.

The definitions in Ordinance 47 shall apply to this Ordinance as if fully set forth herein and words used in the masculine gender may include the feminine and the neuter.

SECTION 2. User Fees.

During Phase I of the MSD Program, the following user fees shall be collected and paid by the operators of solid waste disposal sites in accordance with Ordinances 47 and 48:

- A. Non-compacted solid waste 16¢ per cubic yard delivered.
- B. Compacted solid waste 28¢ per cubic yard delivered.
- C. All material delivered in private cars, station wagons, vans, single and twowheel trailers, and trucks with rated capacities of less than one ton will be computed at the rate of 16¢ per cubic yard with a minimum charge of 35¢ per load.
- D. The user fees for solid waste delivered in units less than a whole cubic yard shall be determined and collected on a basis

proportional to the fractional yardage delivered. For example, 4 1/2 cubic yards of non-compacted solid waste would require a user fee of 72¢.

SECTION 3. Exception.

Inert material, including but limited to earth, sand, stone, crushed stone, crushed concrete and broken asphaltic concrete used at a landfill for cover, diking or road base and for which no dumping charge is made shall be exempt from the user fees.

SECTION 4. Ordinances Repealed.

Ordinances Nos. 33, 36, 37 and 46 are repealed upon the effective date of this ordinance.

SECTION 5. Effective Date.

This ordinance shall take effect at 12:01 a.m. on June 1, 1977.

SECTION 6. Emergency Clause.

State funding of MSD's Solid Waste Division will terminate on June 30, 1977. Since the user fees required by Ordinance 47 are not due and payable until the 20th day of the month following the month of collection, the District must initiate the user fee by June 1, 1977 in order to begin receiving revenues in July. In addition, the projected limited duration of the

existing landfills requires immediate implementation of the Program. An emergency is declared to exist.
