Council President Bragdon convened the Metro Council Work Session Meeting at 2:10 p.m.

### III. Discuss Purpose Statement for I-5/99W Connector

Councilor Hosticka reviewed his memorandum, I-5 to Highway 99W Connector – August 16 Council Work Session, which is attached and forms part of the record. It was emphasized that the Councilors were only giving advice to Councilor Hosticka to take back to the steering committee at this point.

There was discussion with staff about their recommendation.

Councilors weighed-in on Councilor Hosticka's memorandum and the proposal.

Councilor Hosticka said he would take comments and concerns back to the steering committee and then they would have further discussion about the connector. He said that he would report back to the Council the outcome of those discussions and any further possible Metro involvement. He said that he hoped there would be a broader discussion of land use relating to this issue.

### I. Council Direction on Testing New Look Policy Choices

Council President Bragdon reviewed what the Council had asked of the staff regarding this issue.

Robin McArthur, Regional Planning Director, distributed an updated memorandum, which is attached and forms part of the record.

Dick Bolen, DRC Manager, reviewed highlights from the main body of the memorandum distributed by Ms. McArthur.

Mr. Bolen and Paul Couey, Senior Regional Planner, reviewed a schematic and a map displayed at the side of the room for the Councilors.

There was discussion about the base assumptions for the model. After several questions from the Councilors staff elected to review each of the model run proposals outlined in the memorandum.

Michael Jordan suggested that this discussion also be brought to MPAC.
