





- An attorney for almost 17 years, 15 years in private practice. My practice has focussed on contractual and organizational law, specifically property and business law for small to medium size transactions. I have practiced both litigation and transactional law and have substantial experience in negotiating resolutions of disputes. I have represented garbage haulers, homebuilders, contractors in varying speculates, real estate agents and people who have had conflicts with these business people. I have represented people in land use proceedings before hearing officers, Planning Commissions, City Councils, County Commissions, LUBA and the Oregon Court of Appeals.

15 years service on the Board of the Oregon League of Conservation Voters. I was chair of the OLCV from 1987 through 1993. During that time, the revenues of the OLCV grew from about \$12,000 per year to over \$250,000 per year. The OLCV's primary mission is to involve people in the political process by notifying them of the votes

their elected officials make on environmental issues.

- Eight years involved in the Laurelhurst Neighborhood Association. I first served on the Bylaws Committee. I was president for two years and Chair of the LNA Planning Committee for two years. At the beginning of my first term as president, the LNA conducted a survey of residents' opinions about growth. The survey was delivered to all 1800 neighborhood homes and we received over 230 responses. We relayed the results of that survey to the City of Portland and, through our newsletter, we informed neighborhood residents of the land use matters being considered by Portland. We organized residents to give written and oral testimony. We also made a concerted effort to meet with and join with other neighborhood associations regarding issues of common concern. During my tenure, the LNA also repaired several of the arches on the boundaries of Laurelhurst, provided funding for a symphony in Laurelhurst Park and started an annual neighborhood cleanup.

Helped found the Nathan McMurry Thomas Fund and served on the Board for three years. The NMTF organized a Community Unity Concert. We organized volunteers and solicited donations of money and material to build a children's soccer field and to repair and renovate basketball courts in the inner city. Soccer and basketball were Nathan's two favorite sports. We started a children's soccer tournament. We improved the courtyard at Fernwood Middle School, Nathan's school. The NMTF continues planning, funding and finding

donations for community improvement projects.

- I have been interested in growth management issues for many years and have followed those issues in great detail. I have also been interested in regional governments and have followed metro because it

is the most established and advanced of the regional governments. I therefore already know a great deal about the issues addressed by Metro and I can begin service as a Councilor with the background necessary to shorten the learning process. Item No. 4

I am seeking appointment to Metro Region 6 Councilor because I think the most critical issue facing Metro right now is citizen involvement in growth management decisions. In 2000, Metro is likely to face a statewide ballot measure that would abolish Metro. We need to build support for Metro to defeat such a ballot measure. We can build that support by going out into our communities and listening to the concerns of our citizens. We need to involve citizens early, before decisions are made. If citizen involvement consists of telling citizens about decisions that have already been made, we will only alienate them and risk having them vote to abolish Metro.

As described in Item No. 3 above, I have the qualifications to help improve citizen involvement in Metro and in growth management decisions. During most of my adult life, I have volunteered an average of five to ten hours per week encouraging and helping citizens to become involved in the actions taken and decisions made by their elected and appointed officials. I have credibility with many people and I know how to help them become involved.

I believe that Metro is generally pursuing the right policies about growth and growth management in the Portland area. Since Metro is pursuing policies that are largely untested, it must constantly monitor the effects of these policies to see if the assumptions behind the Regional Framework Plan are correct.

Metro must be prepared to adjust if it finds that we are not growing as fast as currently projected, or if we are growing faster. Metro has to determine if the current UGB area can absorb the additional jobs and housing that are projected and be prepared to change if it finds that the negative effects of increased density are greater than anticipated. We have to be willing to slow the rate of UGB expansion if we determine that we do not need to add as much land to absorb the actual growth. Metro cannot stop the growth management planning process with adoption of the Regional Framework Plan. The effects of that plan must be examined and citizens must be continually involved in updating the Regional Framework Plan. This will help build and maintain support for Metro and allow Metro to continue the important work it has started.

I want to help Metro survive the upcoming years. I have the necessary experience and qualifications for these challenges. I can bring people into the process of making growth management decisions and by doing so, build support for Metro.



Good evening Presiding Officer Kvistad and members of the Council. My name is Jackie Dingfelder.

I know you have a full agenda, so I'll be brief. Tonight I want to explain why I want to serve on METRO Council, describe the skills and abilities I offer you, and talk about what I hope to accomplish if I am appointed.

Let me begin with the two reasons why I want this job.

First, I am deeply committed to the issues central to METRO's mission: land use planning, parks and open spaces, transportation, solid waste management and oversight of public facilities such as the Zoo and Convention Center. I have made important contributions in several of these areas, either through professional positions in the public and private sectors, or by service on community boards and committees.

Second, I want to see this region grow wisely, especially during these prosperous times. I can't think of a better place in the world to live, work, and raise a family than right here in this part of Oregon. METRO offers our best chance for ensuring this region remains the livable place it is today.

That's why I want to serve on the METRO Council. But am I qualified for the job? You bet.

Let's start with the skills I would bring to the Council.

I think the greatest strength I offer is my ability to work with all kinds of people. I know how to build consensus among divergent interests as well as create coalitions that work. I listen and I seek positive solutions.

I'm also quite familiar with the legislative process. Some of you originally met me through my work on METRO Council committees MTAC and WRPAC. But I have lobbied and advised members of many city councils, several state legislatures and the U.S. Congress.

I am currently director of the Tualatin River Watershed Council. When I took this job two years ago, the organization lacked a budget, cohesiveness and direction.


