Councilor Hosticka explained that this resolution, which was modeled after the last bond measure allowed for intergovernmental agreements with twenty-eight local jurisdiction park providers. He noted one change from the last bond measure. This resolution called out the amount that each local government would receive. Deputy Council President Park asked what was the total amount for the Intergovernmental Agreements. Council Hosticka responded \$44,000,000.
