CONSIDERATION OF **ORDINANCE NO. 01-896**, FOR THE PURPOSE OF AMENDING THE FY 2000-01 BUDGET AND APPROPRIATIONS SCHEDULE FOR THE PURPOSE OF TRANSFERRING \$20,000 FROM THE GENERAL FUND CONTINGENCY TO INTERFUND TRANSFERS TO FUND COSTS RELATED TO COUNCIL RESDISTRICTING, AND DECLARING AN EMERGENCY

Committee Recommendation: At its April 11, 2001, meeting, the Budget and Finance Committee voted 5-0 to recommend Council adoption of Ordinance No. 01-896. Voting in favor: Burkholder, Bragdon, McLain, Hosticka, Monroe. Voting against: None. Absent: Park, Atherton.

Background: Peggy Coats, Council Analyst, presented the staff report. She explained that, as a result of the Metro Charter Amendment and the 2000 Census, Metro must reapportion Council districts before June 30, 2001. The criteria and process for this redistricting were approved by Council on March 15, 2001 through Ordinance 01-895.

She further noted that the Data Resource Center, which will be generating maps for redistricting, estimates an expenditure of \$20,000 before the end of this fiscal year, which was not included in the budget. This Ordinance would transfer those funds from the General Fund to Interfund Transfers to cover these costs.

Committee Issues/Discussion: There was none.

STAFF REPORT

IN CONSIDERATION OF ORDINANCE NO. 01-896 AMENDING THE FY 2000-01 BUDGET AND APPROPRIATIONS SCHEDULE FOR THE PURPOSE OF TRANSFERRING \$20,000 FROM THE GENERAL FUND CONTINGENCY TO INTERFUND TRANSFERS TO FUND COSTS RELATED TO COUNCIL REDISTRICTING; AND DECLARING AN EMERGENCY

BACKGROUND

In November 2000, voters approved Ballot Measure 26-10 which amends Metro's Charter to, among other things, consolidate the Executive and Council offices and reduce the number of Council districts from seven to six with a Council President elected region-wide, effective January 2003.

In addition, Metro Charter, Section 32(1) states that "...Within three months after an official census indicates that the boundaries of council districts deny equal protection of the law, the council shall change the boundaries to afford equal protection of the law and shall assign councilors to the reapportioned districts."

As a result of the charter amendment and the 2000 census, Metro is legally mandated to reapportion council districts from seven to six in a manner which accords citizens equal protection under the law. This criteria and process for this reapportionment were approved through Ordinance 01-895 on March 15, 2001. Redistricting will be completed by June 30, 2001.

Metro's Data Resource Center (DRC) will be intricately involved in generating proposals for redistricting based on Council criteria. It is estimated that the costs for this work will be approximately \$20,000 and will be accrued prior to the end of FY 2000-01. Because these expenditures were not budgeted, it is necessary to transfer funds from General Fund contingency to Interfund Transfers to cover costs associated with redistricting.

- 2. **Legal Antecedents** Metro Charter, Section 32(1) "Reapportionment of Council Districts After Census", and and Ordinance 01-895, "For the Purpose of Establishing Criteria for Metro Council District Reapportionment and Declaring an Emergency", adopted 15 March 2001.
- 3. Anticipated Effects This amendment will fulfill Metro's charter mandates and reimburse DRC for incurred expenses.
- 4. **Budget Impacts** The General Fund contingency will be reduced by \$20,000.

RECOMMENDED ACTION

That Council adopt Ordinance 01-896, Amending the FY 2000-01 Budget and Appropriations Schedule for the Purpose of Transferring \$20,000 from the General Fund Contingency to Interfund Transfers to Fund Costs Related to Council Redistricting; and Declaring an Emergency.
