PROPOSED ACTION

Resolution 01-3080 declares a proclamation that names July 16 – 27, 2001, as "Car Free and Carefree 2001," in partnership with the Westside Transportation Alliance, the Tualatin Transportation Management Association (TMA), Swan Island TMA, Columbia Corridor TMA and Marquam Hill Partnership.

EXISTING LEGISLATION

Implementation of requirements set forth in the State Transportation Planning Rule and the Federal Transportation Equity Act for the 21st Century (TEA 21) legislation.

BACKGROUND

Since 1999, the Westside Transportation Alliance and partners have promoted a summer Car Free and Carefree promotion, to encourage the public to leave their cars and try using other ways of commuting to work, such as bus, MAX, carpool, bicycle or walking. Metro encourages alternative transportation in the Regional Transportation Plan and will be a sponsor this year by contributing \$100 and by declaring an official proclamation. This activity is consistent with Transportation Demand Management policies contained in the Regional Transportation Plan.

BUDGET IMPACT

Metro's sponsorship is \$100 to the Westside Transportation Alliance.
