#### **EXISTING LAW**

Metro Code, Section 6.01.030, provides that the Council confirms members to the Metropolitan Exposition-Recreation Commission and that Washington County has one seat on that commission. The candidate must be a resident of Washington County.

#### BACKGROUND

Washington County has re-nominated Gary Conkling to the Metropolitan Exposition-Recreation Commission. Mr. Conkling has served both as member of the commission and as chair. The latest revisions to the MERC Code, Ordinance 01-3115888B dated March 15, 2001, stipulated four-year terms for commissioners and Washington County nominated Mr. Conkling to a defined four-year term in the position. Mr. Conkling's term will expire in January, 2006. Metro Executive Officer Mike Burton concurs with Washington County's nomination. An abbreviated bio is attached along with Chair Brian's letter of re-nomination. Mr. Conkling is a resident of Beaverton.
