### **EXISTING LAW**

Metro Code, Section 6.01.030, provides that the Council confirms members to the Metropolitan Exposition-Recreation Commission and that Clackamas County has a seat on that commission. The candidate must be a resident of Clackamas County.

### **BACKGROUND**

Clackamas County nominated Don Trotter to the Metropolitan Exposition-Recreation Commission to replace Alice Norris who has served the county and commission well since 1994. Ms. Norris will be serving until December 31, 2001. In the recently finalized MERC Code, Ordinance 01-888B dated March 15, 2001, Clackamas County was provided the opportunity for a nomination to a four-year term beginning January 1, 2002. Metro Executive Officer Mike Burton concurs with Clackamas County's nomination. Mr. Trotter's resume is attached.
