#### STAFF REPORT

IN CONSIDERATION OF RESOLUTION NO. 08-3949, FOR THE PURPOSE OF CONFIRMING THE COUNCIL PRESIDENT'S APPOINTMENTS TO THE REGIONAL TRAVEL OPTIONS (RTO) SUBCOMMITTEE OF THE TRANSPORTATION POLICY ADVISORY COMMITTEE (TPAC) FOR 2008-2010

#### **BACKGROUND**

The Regional Travel Options (RTO) Subcommittee of Transportation Policy Advisory Committee (TPAC) provides advice to TPAC and the Joint Policy Advisory Committee on Transportation (JPACT) and the Metro Council regarding implementation of programs that promote and support alternatives to driving alone, including carpooling, vanpooling, transit, walking, biking and telecommuting. The RTO Subcommittee has 18 members—14 technical staff from governments in the region and four interested citizen members. The community members represent various interests and parts of the region. Currently all citizen seats are vacant. Public notices of the vacancies were sent to a list of interested parties, neighborhood association newsletters and major and community newspapers. The vacancies were posted on the Metro web site with application instructions and a link to an online application form. Metro received 11 applications and interviewed six individuals.

#### **EXISTING LAW**

Metro Code Sections 2.19.030 (a) and (b) and 2.19.180 (b)(6) states that citizen representatives be nominated through a public application process, appointed by the Metro President and confirmed by the Metro Council.

#### ANALYSIS/INFORMATION

#### 2. Legal Antecedents:

<u>TDM Subcommittee.</u> The TPAC Transportation Demand Management (TDM) Subcommittee was established by Metro Resolution 92 – 1610. Oversight for the development and evaluation of TDM strategies, and formation of final recommendations to Transportation Policy Advisory Committee (TPAC), Joint Policy Advisory Committee on Transportation (JPACT) and Metro Council concerning TDM planning, programming and implementation activities were assigned to the Subcommittee.

Regional Travel Options 5-Year Strategic Plan. The strategic plan established a new vision for the region's transportation demand management programs and proposed a reorganized and renamed Regional Travel Options program that emphasized partner collaboration to implement an integrated program with measurable results. JPACT and the Metro Council adopted the plan through Resolution No. 04-3400, which also renamed the TDM Subcommittee the RTO Subcommittee, and was adopted in January 2004.

3. Anticipated Effects: Approval fills vacancies for citizen members on the RTO Subcommittee.
