13 This matter came before the Washington County Board of
14 Commissioners at their regular meeting of June 23, 1981, and before
15 the Council of the Metropolitan Service District at their meeting
16 of June 25, 1981

17 WHEREAS, through the passage of Ballot Measure #6 in May,
18 1978, the voters of Washington County approved the formation of the
19 Metropolitan Service District (Metro) which includes Washington
20 County; and

21 WHEREAS, the County recognizes that some services or planning
22 programs may be more efficiently and cost-effectively carried out
23 at the regional level; and

24 WHEREAS, both Metro and the County recognize the need for
25 consistent coordination and communication; and

26 WHEREAS, Metro recognizes that the County has direct respon-
sibility to adequately manage use of land within the unincorporated
portions of its boundary; and

1 WHEREAS, Metro recognizes local governments as one of its
2 major constituencies; now, therefore

3 BE IT RESOLVED,

4 1. That the Metro Council commits to presenting the proposed
5 program for local government assistance, planning and other programs
6 related to the dues expenditures annually to the Board of County
7 Commissioners.

8 2. That the Executive Officer of Metro will meet regularly
9 with the Chairperson of the County Commission.

10 3. That Metro stands committed to assist the County in any
11 reasonable way to complete their comprehensive plan without
12 interference.

13 4. That Metro shall make every reasonable effort to consult
14 with and cooperate with jurisdictions prior to taking any formal
15 action affecting local governments.

16 5. That the County intends to work with the Metro Council in
17 a cooperative effort and help to define services which Metro may
18 provide to the benefit of County residents.


19 6. That the County will send an elected representative to meet
