2. Tour - Metro Central Transfer Station & Hazardous Waste Facility (8:15 - 9:30)

Tour highlights will include a mechanical process that recovers waste for use as fuel pellets, on-site hand separation of recyclables from waste, and compaction of waste for truck transfer to the Columbia Ridge Landfill. A tour of the adjacent hazardous waste facility will focus on Metro's program to manage hazardous waste according the to "reduce, reuse, recycle, recover, and landfill" hierarchy.

3. Staff Briefings, Questions and Answers (9:45 - 11:30)

Bruce Warner and REM Staff

Staff will present short briefings on the subjects listed below. The majority of time, however, will be devoted to questions from new SWAC members about Metro and regional solid waste management. Fact sheets and other orientation materials will be provided at the meeting.

Regional Solid Waste Management Plan. Marie Nelson, Solid Waste Planning Supervisor, will present an overview of the regional plan, how it was developed, the plan's major goals, and some of the waste management practices recommended as a means to accomplish those goals.

Solid Waste Facility Regulation. Andy Sloop, Franchise Administrator, will discuss a current project to revise Metro's Code for regulating solid waste and facilities. He and Doug Anderson will also review some of the emerging policy issues that stem from changes in the industry (e.g., consolidation, vertical integration) and from changes in the regional solid waste system (e.g. new material recovery facilities, out of region landfills.).

Metro Rate Structure and Information System. Roosevelt Carter, Budget and Finance Manager, will review Metro's current rate structure, revenue sources, and uses for the revenue.

Doug Anderson, Acting Waste Reduction Manager, will explain the Solid Waste Information System for tracking and reporting information.
