DESCRIPTION

Function as a member of the animal nutrition and veterinary care team with a primary responsibility for food and supply receiving and storage, emergency orders, and food preparation and delivery throughout the Zoo. Serve as a resource to Animal Keepers, operate food processing and distribution equipment, prepare and dispense animal food items and supplies, and assist in the overall operations of the animal commissary including purchasing, stock keeping, and maintaining the facility and its equipment as well as email and records duties.

DISTINGUISHING FEATURES

The Nutrition Technician 1 is distinguished from Nutrition Technician 2 by having responsibility to coordinate food and supply unloading, receiving, storage, preparation and delivery throughout the zoo. The Nutrition Technician 1 works under the direction of the Nutrition Technician 2.

DUTIES AND RESPONSIBILITIES

- 1. Functions as member of the nutrition and veterinary care team with a primary responsibility for performing and coordinating food and supply unloading, receiving, storage, preparation and delivery throughout the Zoo.
- 2. Performs and helps coordinate emergency order functions, as required, to work with Animal Keepers and other colleagues on special order availability and trips to grocery and other stores.
- 3. Prepares diets, with assistance of the Nutritionist or Nutrition Technician 2, for all Zoo animals; consults with Animal Keepers regarding eating habits of animals and feeding methods that are natural and healthful to animals.
- 4. Maintains food inventory and inspects food supplies to ensure freshness and proper rotation.
- 5. Places orders for food supplies in the absence of the Nutritionist or Nutrition Technician II.
- 6. Off-loads trucks, receives supplies, and verifies shipments against orders and invoices.
- 7. Prepares Zoo animals' diets by following nutritional guidelines and cost factors.
- 8. Assembles and sets out daily food deliveries; delivers diets to all animal areas.
- 9. Helps maintain and process various records associated with requisitions, purchase orders, invoices, feedings, inventories, etc.
- 10. Inspects commissary freezers, coolers and other equipment and arranges for necessary maintenance.
- 11. Performs and coordinates off-loading of all commissary deliveries. This may require the use of specialized equipment including pallet jacks, forklifts, hay loaders, etc.

12. Compiles data for reports.
