## **GENERAL STATEMENT OF DUTIES**

Serves as a Lead employee providing direction to a crew of set-up and housekeeping maintenance employees at the Oregon Convention Center. Duties also include performing routine clean-up and set-up tasks involved in facility maintenance. Reports to a Set-up or Event Supervisor. Specific duties vary from shift to shift as follows: Swing shift duties primarily involve set-up; night-shift duties primarily involve cleaning; day shift duties involve some setup, cleaning and customer service as required.

#### SUPERVISION RECEIVED

Supervision is received from the Setup or Event Supervisor.

### SUPERVISION EXERCISED

Leads the work of Utility Workers I, II and temporary maintenance laborers.

### EXAMPLES OF PRINCIPAL DUTIES

An employee in this position may perform any of the following essential job duties and must be able to do so with or without reasonable accommodation. However, this list is not intended to include all of the specific tasks which an employee in this position may be expected to perform.

- Leads the work of Utility Workers I, II and temporary maintenance laborers including assigning and monitoring work. Coordinates schedules and work assignments.
- Performs cleaning and sanitary maintenance duties at OCC including sweeping, mopping, waxing, vacuuming, dusting and emptying trash containers.
- Performs restroom maintenance and cleaning tasks including replenishing towels, tissue and soap.
- Dusts and polishes fixtures and furniture; cleans trash containers and ashtrays.
- Cleans mirrors, fixtures, windows, walls and drinking fountains.
- Assists in keeping outside premises in an orderly condition as may be required for specific event demands.
- Performs setup and break down of tables, chairs, bleachers, ramps, dance floors, air walls, staging and hangs drapes as required for conventions, meetings and other OCC events utilizing schematic drawings and narrative descriptions.

- Operates elevator as required for transport of material.
- Monitors building during shows to ensure restrooms are stocked, trash containers are emptied and water services are replenished.
- Performs related duties as assigned.
