2. T.I.G.E.R. DISCRETIONARY GRANTS OPPORTUNITY (TRANSPORTATION INVESTMENT GENERATING ECONOMIC RECOVERY) FOR ACTIVE TRANSPORTATION PILOT PROJECT

Andy Cotugno discussed the stimulus opportunities that Metro had available. The deadline is September 15th for the application process and it would be a full-court press as Mr. Cotugno described. Lake McTighe presented background information and potential projects with the TIGER Grant Opportunity. There was a large list of potential projects and there will need to be one for urban, one for rural, and one for connecting nature. Mr. Cotugno discussed the potential of receiving the TIGER grants. Council discussed their views on having Metro's staff carry out the application process. There was widespread agreement on the next steps for the process.

Andy Shaw Metro Infrastructure Finance manager, discussed the EAG meeting series that has been taking place. Council discussed potential corridors that have been discussed and what they hope would get back to the EAG meetings representing their concerns.
