CONSIDERATION OF RESOLUTION NO. 84-459 APPOINTING SUSAN McGRATH TO THE METRO INVESTMENT COMMITTEE FOR A THREE-YEAR TERM

FACTUAL BACKGROUND AND ANALYSIS

On December 2, 1982, the Metro Council adopted Resolution No. 82-378 which created an Investment Committee for the purpose of reviewing existing investment practices, making policy recommendations to the Council, and monitoring and reporting to the Council on investment activity pursuant to established policy. The Resolution established the membership of the Investment Committee as three Council members (Audit Committee) and three citizens of the community who are expert in fiscal and investment matters, appointed by the Presiding Officer and Chair of the Audit Committee, and ratified by the Council.

Resolution No. 83-379, adopted January 6, 1983, appointed Susan McGrath, Rebecca Marshall and Dave Smith as the citizen members of the Investment Committee.

Resolution No. 83-386, adopted January 27, 1983, set the terms of service for the citizen appointees on the Metro Investment Committee. The initial citizen appointees to the Investment Committee were assigned terms of service as follows: Susan McGrath, one year; Dave Smith, two years; and Rebecca Marshall, three years. Terms of service after the initial appointments were set for three years.

The term of Susan McGrath expired on January 27, 1984.
Ms. McGrath has indicated that she would be willing to accept reappointment for a three-year term and the Presiding Officer and Chair of the Audit Committee concur with the reappointment of Ms. McGrath.

EXECUTIVE OFFICER'S RECOMMENDATION

The Executive Officer concurs with the recommendation of the Presiding Officer and Chair of the Audit Committee and recommends Council ratification of the reappointment of Ms. McGrath to the Investment Committee for a three-year term.

COMMITTEE CONSIDERATION AND RECOMMENDATION
