FACTUAL BACKGROUND AND ANALYSIS

The Fiscal Year 1997-98 Proposed Budget has been forwarded to Council for consideration. Ordinance No. 97-679, presented to Council on February 20, 1997, is the formal instrument by which the budget will be adopted. Final action to adopt the budget is scheduled for the end of June 1997.

Prior to adoption, ORS 294.635, Oregon Budget Law, requires that Metro prepare and submit the District's approved budget to the Tax Supervising and Conservation Commission by May 15, 1997. The Commission will conduct a hearing during June 1997 for the purpose of receiving information from the public regarding the Council's approved budget.

This action will formally approve the Council's Fiscal Year 1997-98 Budget, and direct the Executive Officer to submit the approved budget to the Tax Supervising and Conservation Commission for public hearing and review.
