ISSUE & BACKGROUND

Metro Council approved an investment in climate change analysis and coordination in order to meet Oregon's greenhouse gas reduction (GHG) goals set in 2007 by the state legislature. The state's greenhouse gas reduction targets call for a stop to emission increases by 2010, a 10 percent reduction in emissions below 1990 levels by 2020 and a 75 percent reduction in emissions below 1990 levels by 2050.

Investment Desired Outcomes:

- Strong technical foundation for good decision-making;
- Climate change impact is key factor in policy and program decisions;
- Successful collaboration with regional partners.

Activities Proposed:

- Developing regional greenhouse gas emissions tools to help Metro and the region assess and prioritize program options;
- Applying a greenhouse gas emissions "lens" to key Metro initiatives;
- Working with regional partners to identify best management practices and opportunities for collaboration; and
- Identifying specific project investment opportunities.

Milestones/Progress to date:

- Developed a draft regional greenhouse gas emissions inventory to inform strategic action;
- Hosted a climate change communications workshop for regional partners;
- Coordinated the Portland Metro Climate Prosperity engagement meetings attended by more than 150 regional stakeholders;
- Launched a regional partnership with the University of Oregon to conduct a Lower Willamette River Basin Climate Preparation Strategy; and
- Created an internal cross-functional team to begin scoping the HB 2001 GHG scenario planning requirements.
