BACKGROUND

Mr. Paul Manson offers a well-rounded understanding of both transportation and land use elements and would be able to draw on multiple experiences from his past and present academic, professional and volunteer experiences.

Mr. Manson's primary interests are in land development and transportation policy, with a focus on bicycle and pedestrian opportunities; and environmental and sustainability policy. The combination of his master's work in natural resource policy and management matched with his employment experience as an environmental and sustainability planner, complements current Multnomah County citizen member Matt Berkow's non-motorized transportation focus. Over the past decade, Paul has been active in the Portland region through volunteering and professional activities. His interests include land development and transportation policy, with a focus on bicycle and pedestrian opportunities; and environmental and sustainability policy. Sullivan's Gulch Trail Corridor Committee

The Sullivan's Gulch trail is proposed to parallel I-84 from the Eastside Esplanade, pass through Gateway and provide a connection with 122nd Avenue. The committee is an ad-hoc group of neighborhood and business representatives that are along the proposed route. Paul has volunteered through meeting facilitation, transportation policy advocacy, and web and social media outreach. Recently the group played an important role in elevating the value of trails as transportation tools in the Portland Bicycle Master Plan. The group strongly believes that trails will provide a critical role in transportation and recreation in the coming decades. As a nearby resident and daily bike commuter, the trail is a personal passion.

Multnomah Citizen Budget Advisory Committee

Paul serves on the Multnomah County Citizen Budget Advisory Committee that reviews the Department of County Management and the Department of Community Services. The committee interviews department staff and program managers and prepares budget recommendations for review by the County Board. The programs covered by this CBAC include land use, transportation planning, bridges, finance, and taxation and assessment.

City Club of Portland

As a member of the City Club of Portland, Paul was actively engaged in a series of research committees. Research included several ballot measure studies on judicial reform and management. The most extensive research Paul participated in was the 18 month study of the Portland Development Commission (PDC). WHEREAS, pursuant to ORS 279A.060 and Metro Code 2.04.058 the Metro Council is designated as the Public Contract Review Board for the agency;

WHEREAS, Metro Code 2.04.058 requires Council approval for contract amendments that exceed \$25,000 and over 5% of the initial contract value for public improvements;

WHEREAS, The Sustainability Center has determined that the additional work in this change order is necessary and appropriate, and is within the contingency budget for the project;

WHEREAS, under the direction of the Graham Oaks Construction Manager, JP Contractors, Inc. is constructing the Graham Oaks Nature Park improvements in accordance with the project specifications and schedule;

WHEREAS, the original contract was awarded as a result of an open competitive bid process with JP Contractors, Inc. being deemed the lowest responsive and responsible bidder;

WHEREAS, the original contract amount was \$1,483,225.50 and the proposed contract amendments are projected to increase the total contract amount to \$1,645,068.50. The additional work has been reviewed by the Graham Oaks Construction Manager and the project landscape architect and has been approved as appropriately priced;

WHEREAS, the Metro Procurement Officer believes that the amending the existing contract with JP Contractors, Inc. is appropriate and that such action is in the best interests of Metro and competing the additional work would be impractical; and

BE IT RESOLVED that the Metro Council acting as the Public Contract Review Board authorizes the Procurement Officer to execute contract amendments up to the amount of \$1,645,068.50 with JP Contractors, Inc. for the Graham Oaks Nature Park project.

STAFF REPORT

IN CONSIDERATION OF RESOLUTION NO. 10-4109, RESOLUTION OF METRO COUNCIL, ACTING AS THE METRO CONTRACT REVIEW BOARD, FOR THE PURPOSE OF APPROVING A CONTRACT AMENDMENT FOR GRAHAM OAKS NATURE PARK DEVELOPMENT PROJECT

BACKGROUND

An open, competitive Request for Bid (RFB) was issued for the Graham Oaks nature park project in 2009. In accordance with Metro Code, the lowest responsive, responsible bidder was selected, which was JP Contractors, Inc. of Portland, Oregon.

The project specifications and design drawings were prepared by the landscape architectural firm Greenworks, PC and adequately represented the scope of the project.

This contract was awarded on September 22, 2009 in the amount of \$1,483,225.50 and work began on September 28, 2009. The Construction Manager reports that this project has progressed as planned and that JP Contractors, Inc. has provided construction services in accordance with the contract.

Fiscal, social and environmental aspects of the Graham Oaks Nature Park project continue to be evaluated during the construction of the project. During the course of construction, a number of the design details and material choices have been reconsidered with regard to the source for products, pavement durability, long term maintenance and the user experience at the Nature Park.

The Contractor recommended, and the suggestion was accepted by the Metro Construction Manager and his managers that refinements to the pavement materials would result in a finished product that would better align with the sustainability goals of the project and reduce long term maintenance. Pavement refinements include material substitutions, adding structural steel to concrete pavement sections and installing a geo-textile fabric under the asphalt and gravel trails. These improvements will increase the structural stability and durability of the trails, minimize root penetration and weed growth through the trail bed, allow for improved accessibility for people of all abilities. The total additional costs for these pavement refinements would be \$80,963.00.

The Contractor also recommended that Metro consider a State of Oregon company as a supplier for the site furnishings for the project. It has been determined by the Metro Construction Manager and landscape architect that Natural Structures, of Baker City, Oregon can provide products that are equal to, or better than, those products specified in the Contract Documents. Natural Structures is also a HUBZone Certified Supplier. A HUBZone company is one that operates and employs people from Historically Underutilized Business Zones (HUBZones). The federal government administers this program and designates small businesses as HUBZone certified based on the size of the company, ownership, company location and percentage of work force residence. Small businesses that are located in these economically distressed communities receive priority for Federal Government purchases in an attempt to revitalize economies and stimulate business. Baker City is a certified Rural HUBZone within the State of Oregon. Another advantage of using Natural Structures to provide these furnishings is that they are already providing a significant element to the project (eco roof picnic shelter) and product warranty issues and replacement parts would be more convenient in dealing with one manufacturer. The total additional costs for the locally supplied site furnishings would be \$1,800.00 or a 9.1% increase over those items originally specified.

Prior to the bid process, Metro secured a State of Oregon Local Government Grant for \$500,000. This grant, in addition to a favorable bid (which was under the engineer's estimate), allowed the project team to consider aspects of the nature park master plan that were neither designed nor bid based on earlier budgetary concerns. Metro staff and management have reviewed the trail network and support the development of 1,800 lineal feet of additional trails through the conifer forest area found on the south side of the site. Providing a defined, accessible trail in this area will offer access to one of the most desirable areas on the site and hopefully prevent the development of additional social trails already found in this area. The total additional costs for the additional trail development would be \$68,000.00. This work would include drainage improvements, low land crossings and viewpoints.

Metro requested that the Contractor fabricate the steel posts for the all the interpretive signage on site and prepare the concrete seat walls for placement of interpretive panel posts. The total additional costs for this work would be \$9,050.00.

Metro requested that the Contractor provide and install native trees along the eastern property line to provide privacy screening for those residences most affected by the local trail connection from the Tonquin Trail to the Park at Merryfield. The total additional cost for this work would be \$2,030.00.

The Metro Construction Manager reviewed these additional items and agreed the work is necessary and can be paid within the existing project budgets. The consulting landscape architect for the project also reviewed the requests and verified that the work is outside of the existing contract scope and reasonably priced, a conclusion supported by the Metro Procurement Officer.

The total for all change orders is \$161,843.00. There are no previous change orders. This is 10.9% of the original contract amount which is lower than industry standard for construction work in the public sector and we believe represents effective cost control and project management. While Metro's procurement rules limit construction change orders to five percent, the Oregon Attorney General's Model Rules set this amount at 20 percent.

Metro Code 2.04.058, Public Contract Amendments, requires Metro Council approval of contract amendment or change orders that exceed \$25,000 or five percent of the original contract value. The Metro Procurement Officer has deemed this amendment to be appropriate and

reasonably related to the original scope of work, and therefore, believes the amendment is in Metro's best interest to approve.

The Sustainability Center will continue to manage and administer this contract to ensure these exhibits are constructed in accordance with the contract, including all plans and specifications. The Graham Oaks nature park project is scheduled to open in the fall of 2010.

ANALYSIS/INFORMATION

- 1. Known Opposition: None known.
- 2. Legal Antecedents: Metro Code 2.04.058, ORS Chapter 279C.
- 3. Anticipated Effects: Construction will continue on the Graham Oaks nature park project under the direction of the Construction Manager and in accordance with schedules.
- 4. **Budget Impacts:** These change orders fall within budgeted contingency amounts. Total contract amount for JP Contractors will be \$1,645,068.50. The total budget for construction included in the CIP for this project is \$2,542,500.00, with a remaining contingency of \$897,431.50.

RECOMMENDED ACTION

Metro Council, acting as Public Contract Review Board, approves the attached contract amendment representing change order #1, with JP Contractors, Inc.

- 5. That this Ordinance being necessary for the health, safety, and welfare of the Metro area because an emergency is declared to exist, and this Ordinance shall take effect immediately, pursuant to Metro Charter Section 39(1).

Exhibit A to Ordinance No. 10-1230 Metro Code Title IV, Chapter 4.01, Section 4.01.060

4.01.060 Rules of Conduct for Public Within Zoo Premises

The following rules of conduct and regulations shall be applicable to all members of the public within Zoo premises. In addition to penalties provided for herein or by applicable law, adherence to these standards of conduct shall be a condition of admission to the Zoo premises.

(a) Limited Right-of-Entry. Public entry into the Zoo premises is prohibited except during hours of public operation as established pursuant to Section 4.01.040. Members of the public attending special events after normal hours of operation may do so only as specifically authorized by the Zoo Director, and may only enter those portions of the Zoo premises specifically authorized for the conduct of the special event.

(b) Admission Fee Required. All members of the public entering the Zoo shall do so only after payment of the applicable admission fee except as entry may be specifically authorized by the Zoo Director or Chief Operating Officer.

(c) <u>Destruction Prohibited</u>. No member of the public may destroy, damage or remove any property including plants located on Zoo premises.

(d) <u>Protection of Zoo Animals</u>. No member of the public shall:

- Kill, injure, or disturb any animal by any means except to secure personal safety;
- (2) Pet, attempt to pet, handle, move, or remove the animals except where expressly permitted;
- (3) Feed the animals except when and where expressly permitted;
- (4) Catch, attempt to catch, trap, remove, or kill any free roaming animals inhabiting the premises;
- (5) Go over, under, between, or otherwise cross any guardrail, fence, moat, wall, or any other safety barrier; or
- (6) Except as provided in paragraph (3), throw any object or material at any animal or into any animal enclosure or exhibit area.

(e) <u>Conformity with Signs and Emergency Directions</u>. Members of the public shall comply with official signs of a prohibitory or directory nature, and with the directions of Zoo employees.

(f) <u>Littering</u>. Littering, dumping or any other disposal of rubbish, trash, or other wastes, at the Zoo by any member of the public other than in designated receptacles is prohibited.

(g) <u>Alcohol</u>. Possession or consumption by any member of the public on the Zoo premises of any alcoholic beverage of any nature whatsoever other than beverages purchased from Zoo employees or as expressly authorized in writing by the Zoo director is prohibited.

(h) <u>Sound Amplification Devices</u>. Possession or use by any member of the public of musical instruments, radios or other electric sound-producing or amplification devices that make or emit sounds audible to anyone other than the user of the device is prohibited.

(i) <u>State and Local Laws</u>. All members of the public on Zoo premises shall comply with all provisions of the Oregon Criminal Code, the City of Portland Police Code, <u>including but</u> <u>not limited to regulations and prohibitions pertaining to</u> <u>firearms and dangerous or deadly weapons</u>, and other provisions of applicable law.

(j) <u>Soliciting</u>, Vending, and the Distribution of <u>Handbills</u>. The soliciting of alms and contributions, commercial soliciting, and vending or distribution of samples of any kind, the display or distribution of commercial advertising, and the disseminating of written materials, and canvassing for political, charitable, or religious purposes by members of the public are prohibited within the Zoo premises.

(k) <u>Animals</u>. Except for assistance animals authorized by ORS 346.685, no animals shall be brought on the premises by any member of the public. Use of assistance animals at the Zoo shall be subject to reasonable guidelines established by the Zoo Director and approved by the Chief Operating Officer.

(1) <u>Photographs for News, Advertising, or Commercial</u> <u>Purposes</u>. No photographs for advertising or any other commercial purpose may be taken on the premises by any member of the public unless officially authorized by the Zoo Director.

Exhibit A to Ordinance No. 10-1230 Metro Code Title IV, Chapter 4.01, Section 4.01.060

(m) <u>Weapons and Explosives</u>. No member of the public while on the premises shall÷

- (1) Carry a firearm, loaded or unloaded. "Firearm" is defined to include a pistol, revolver, gun, rifle or other ordinance, including a miniature weapon, which projects a missile or shot by force of gunpowder or any other explosive, by spring or by compressed air.
 - (2) Carry a dangerous or deadly weapon. "Dangerous or deadly weapon" includes a firearm, metal knuckles, straight razor, weapon of the type commonly known as a nunchaku, blackjack, sap or sap glove, slingshot, bomb or bombshell, and any type of knife other than an ordinary pocketknife with a blade not longer than three and one-half inches (3 1/2"). When carried with intent to use the same unlawfully against another, "dangerous or deadly weapon" also includes any instrument or device capable of inflicting injury to the person or property of another.

(3) Carry carry, discharge, or set off any fireworks or explosives of any nature.

4.01.110 Allocation of Zoo Tax Base - Repealed

(a) Upon approval of a tax base submitted on May 15, 1990, to the voters of Metro, the Council shall allocate the entire amount of the tax base to the operation and maintenance of the Zoo. The allocation shall continue until the voters of Metro approve a new tax base or Metro ceases to operate and maintain the Zoo.

(b) Any constitutionally authorized increase in the tax base approved by the voters on May 15, 1990, subsequently levied by the Council shall be used exclusively to operate and maintain the Zoo.

Hunting is prohibited. No person shall discharge a firearm, air rifle, spring gun, bow and arrow or other weapon in or over any park except in areas specifically designed for that purpose. All weapons which are brought into parks areas shall be completely unloaded and kept in the owner's vehicle at all times.

BACKGROUND

The Metro Code, Section 6.01.030(a), gives Metro Council President sole authority to appoint all members of the Metropolitan Exposition-Recreation Commission, subject to confirmation by the Metro Council. Section 6.01.030(d)(3) of the Metro Code allows the Council President to nominate a candidate for appointment for the Metro Council's consideration. Under Section 6.01.030(g) of the Metro Code, vacancies are filled pursuant to the procedure governing initial appointments.

The Metro Council President has appointed Karis J.A. Stoudamire-Phillips as a candidate for membership on the Commission. The Council President has submitted his appointment of Ms. Stoudamire-Phillips to the Metro Council for confirmation. If confirmed, Ms. Stoudamire-Phillips would, pursuant to Metro Code, Section 6.01.030(g), serve a 4-year term beginning January 7, 2010 and ending December 31, 2013.
