Councilor Park provided background information on the ordinance and explained firearm laws relating to the ordinance. Dan Cooper, Metro Attorney, explained legal specifics. Councilor Hosticka asked about related materials associated in the packet. Councilor Park stressed responsible firearm use and control.

Councilor Collette introduced the resolution and described budget specifics. Councilor Burkholder asked about number differences and whether or not systems were in place to alleviate problems associated with amendments within the resolution. Teri Dresler, interim Zoo Director, described implemented processes to alleviate and manage contracts and processes properly at the Zoo. President Bragdon asked if there had been an estimation error. Ms. Dresler said it was a mix of mis-estimation and defining scope. Michael Jordan, COO, discussed contract management and front-end and back-end processes involved in the resolution and the need for amendment. Councilor Park asked about contract thresholds for Council action. Darin Matthews, Procurement Officer, discussed the Metro contract list and approval processes.

Councilor Collette closed discussion on Resolution No. 10-4114.
