3. INDEPENDENT AUDIT REPORT FOR FINANCIAL ACTIVITY DURING FY 2008-2009: PRESENTATION

Suzanne Flynn, Metro Auditor, introduced the audit process and provided background for the external audit presentation. She introduced staff involved in the audit and described legislation to come before Council for a vote in the following weeks – one resolution to accept the external financial audit (presented), and one ordinance to revise Metro code language regarding the formation of an audit committee. Audit results were presented. A Powerpoint presentation was presented.

Councilor Burkholder asked about standards and implications, and retroactive values dating back to 1980 – and the importance of "doing it right." Councilor Liberty asked about schedule of expenditures for federal awards. Councilor Park asked about transparency in federal transactions.

Margo Norton, Finance and Administrative Services Director, provided a summary of the audit and next steps, including timelines and budget processes. She discussed the budget as a policy, plan, and aspiration. Ms. Norton discussed financial planning in relation to Metro plans and on-the-ground implementation of various projects and programs. Ms. Norton discussed accounting procedure and processes, including a summary of the audit report. She thanked staff for their hard work and success. Councilor Collette thanked Ms. Norton for her and staff's hard work. She said it was validated. Councilor Harrington thanked Ms. Norton for their hard work. Councilor Park discussed insurances and assurances regarding fund use and transparency. Councilor Liberty noted the importance of audit responses.

Councilor Park discussed proper market competition as an agency and regarding MERC operations. He discussed efficiency. Councilor Burkholder asked about the authority relative to guiding the COO within code changes. Dan Cooper, Metro Attorney, said it was specific to operation of facilities.
