

## MINUTES OF THE METRO COUNCIL MEETING

Thursday, April 1, 2010  
Metro Council Chamber

Council President Bragdon convened the Regular Council Meeting at 2:00 p.m.

### 1. INTRODUCTIONS

Ron Swaren, Portland, provided testimony on Columbia River Crossing issues including freeway and bridge designs. He noted congestion problems and repair logistics.

#### **4. ORDINANCES – FIRST READING**

##### **4.1 Ordinance No. 10-1235, Adopting the Annual Budget for Fiscal Year 2010-11, Making Appropriations, Levying Ad Valorem Taxes and Declaring an Emergency.**

Michael Jordan, COO, provided a budget presentation to Councilors (see attachments “2010-11 Proposed Budget, Budget Presentation, April 1, 2010”). A PowerPoint presentation was given (see attachments). He discussed different Metro budget issues and visitor venues. Margo Norton, Director of Finance and Regulatory Services, provided a “Budget by the Numbers” section. Suzanne Flynn, Metro Auditor, provided a budget presentation for the Office of the Metro Auditor. MERC Commissioner Alisa Dozono and Cheryl Twete, interim MERC General Manager, provided the budget presentation for MERC (Metropolitan Exposition and Recreation Commission).

Councilor Park asked about renewal replacement levels. Commissioner Dozono noted aging facility concerns. Ms. Twete noted opportunities. Mr. Jordan introduced Doug Anderson, Solid Waste and Compliance Manager. He provided a proposed solid waste rates presentation (see attachments). Councilor Hosticka asked about fuel and connection to rates. He asked about surcharges on paint sales. Mr. Jordan wrapped up with discussion on upcoming budget considerations. He noted the difficult economic times and thanked staff involved in the budget proposal. Councilor Hosticka asked about brownfield issues. He discussed collaboration with jurisdictions on regional investments and priorities. Councilor Harrington discussed impacting human lives, and that the budget was successful. Councilor Liberty asked about healthcare and PERS issues. Councilor Park thanked Mr. Jordan and staff for their work. He noted successes in transparency and goals met. Councilor Collette noted improvements in the budget process throughout the years. She noted positive positions relative to other governments. Councilor Burkholder noted deliberate and intentional investments. He said it reflected back on organizational arrangements and successes.

Council President Bragdon opened a public hearing on Ordinance No. 10-1235.

Council President Bragdon closed the hearing.

Council President Bragdon assigned Ordinance No. 10-1235 for second reading on June 17<sup>th</sup>, 2010. Public hearings would also occur in the meantime, the first scheduled for the April 15, 2010 regular Council meeting.
