MINUTES OF THE METRO COUNCIL MEETING

Council President Bragdon convened the Regular Council Meeting at 2:00 p.m.

1. INTRODUCTIONS

Councilor Burkholder noted a Metro Award received.

3. COMMUNICATIONS PROJECTS PRESENTATION: BIKE THERE!

Pam Peck, Metro Communications Manager, introduced the "Bike There!" presentation. Mike McCarthy, Senior Project Engineer, City of Tigard presented the Tigard 'Bike There!' map. Matthew Hampton, Senior Transportation Planner for Metro, outlined what was new about the eighth edition of the Bike There! map. Councilor Burkholder asked about specific bicycling routes. Councilor Harrington asked about access to "Bike There!" maps. She asked about grant opportunities. President Bragdon asked about route methodologies and identification of trails versus roads and visual hierarchies. Councilor Collette appreciated notes on safety and the ability to identify different safety options.

4. FINANCIAL CONIDTION FY00-FY09 AUDIT PRESENTATION

Suzanne Flynn, Metro Auditor, provided the financial condition audit report to Council. She provided a Powerpoint presentation to Council (see meeting packet). President Bragdon asked about general fund specifics. Ms. Flynn discussed rolling funds grouped together from a reporting perspective. President Bragdon asked about forecasting and adjustments. Ms. Flynn said she did not know definitive effects for Metro specifically, but would further study. Margo Norton, Finance and Administrative Services Director, noted specific values of the presented graphs and discussed the ability to focus on issues and priorities, in addition to 'focusing down.' She said the report gave citizens an alternative view. Councilor Park discussed separating and noting specific fund information. Ms. Flynn and Ms. Norton concluded the presentation.

Deena Platman, Metro Principal Planner, discussed timelines and matching specifics. Councilor Park asked about allocations and planning processes. President Bragdon noted the value of the dollars in relation to system performance. Councilor Collette closed discussion on the resolution.
