STAFF REPORT

IN CONSIDERATION OF RESOLUTION NO. 03-3326 FOR THE PURPOSE OF CONFIRMING APPOINTMENTS OF ALAN HOLZAPFEL, NEAL ARDEN, MARIA ELENA ALVARADO AND MARK KIRCHMEIER TO THE NORTH PORTLAND REHABILITATION AND ENHANCEMENT COMMITTEE (NPREC)

BACKGROUND

Four vacancies have occurred in the NPREC membership with terms expiring in April 2003. A process to fill the positions was launched on March 14, 2003, with a mailing to more than 450 individuals residing in the enhancement boundary and to neighborhood groups, business associations and the North Portland Neighborhood Service Office. A cover letter from Rex Burkholder, Metro Councilor and North Portland Enhancement Committee Chair, requested that candidates complete and return an application to Metro by April 4, 2003. A news release was distributed to local community newspapers. The application was posted on Metro's web site. A copy of the cover letter, application and news release are attached.

A review panel was selected to consider applicants. The panel was comprised of Pam Arden (neighborhood activist, grant recipient and original member of the enhancement committee), Tom Griffin-Valade (North Portland Neighborhood Office District Coordinator), Lee Jenkins (director of University Park Community Center), Carmen Rubio (North Portland representative from City of Portland Commissioner Cruz's office) and Karen Blauer, Metro community enhancement coordinator.

Two candidates applied for both the St. Johns and University Park openings; one each for the Arbor Lodge and Kenton positions. The candidates from St. Johns and University Park neighborhoods were interviewed. The panel came to unanimous consensus on Maria Elena Alvarado and Mark Kirchmeier. The candidates who ran unopposed, Alan Holzapfel (Arbor Lodge) and Neal Arden (Kenton), are well known and highly regarded for their respective work in the community. They were, therefore, not interviewed. Candidates' applications and the interview questions are attached.

ANALYSIS/INFORMATION

- 1. Known Opposition. There is no known opposition to the proposed legislation.
- 2. Legal Anteccedents. Chapter 2.19 of the Metro Code Relating to Advisory Committees; Section 2.19.140 provides for a North Portland Rehabilitation and Enhancement Committee (NPREC); and Section 2.19.140 authorizes representatives for Committee membership.
- 3. Anticipated Effects. Adoption of this resolution would confirm the appointment of four new citizen members of NPREC.
- 4. Budget Impacts. There are no known costs associated with implementation of this legislation.

RECOMMENDED ACTION

The Metro Council President recommends adoption of this resolution to confirm the appointment of these individuals to serve on the North Portland Rehabilitation and Enhancement Committee.
