WHEREAS, the existing Child Care Operations Agreement with MetroKids was last approved by Metro Council on April 28, 2005, via Metro Council Resolution No. 05-3576 ("For the Purpose of Authorizing Execution of a Multi-year Contract to Provide Daycare Services at the Metro Regional Center"), for a 3-year term, allowing for two 1-year extensions, expiring June 30, 2010; and

WHEREAS, Metro entered into subsequent amendments to the Child Care Operations Agreement (Amendment No. 1 amending the Scope of Work and Amendments 2 and 3 for allowing two 1-year extensions); and

WHEREAS, the Chief Operating Officer wishes to further extend the Child Care Operations Agreement with MetroKids for one additional year (Amendment No. 4); and

WHEREAS, pursuant to Metro Code Section 2.04.026 (l)(a), the Chief Operating Officer must obtain the authorization of the Metro Council prior to executing the Daycare Operations Contract Amendment No. 4; now therefore

The Metro Council authorizes the Chief Operating Officer to execute an Amendment No. 4 to the Child Care Operations Agreement Contract, extending the agreement for one year, in a form approved by the Office of the Metro Attorney.
