Councilor Harrington convened the Regular Council Meeting at 2:00 p.m.

1. INTRODUCTIONS

Councilor Harrington recognized Budget and Finance and Administrative Services (FAS) staff for their award 'Certificate of Achievement in Financial Reporting.' She discussed the award and recognized staff. Michael Jordan, COO, and Margo Norton, FAS Director, discussed the great work Metro staff do.

Councilor Liberty introduced the resolution and Mary Rowe, Human Resources Director. She discussed specifics of the settlement and resolution. Councilor Burkholder asked about different venue clauses within the settlement.

Vote: Council President Bragdon and Councilors Burkholder, Harrington, Hosticka and Liberty voted in support of the motion. The vote was 5 aye, the motion passed.

5.2 **Resolution No. 10-4170,** For the Purpose of Proclaiming a Recommitment to Full Implementation of the Americans With Disabilities Act.

Motion:	Councilor Liberty moved to adopt Resolution No. 10-4170.
Seconded:	Councilor Harrington seconded the motion

Councilor Liberty introduced the resolution and discussed the ramifications and results of the Americans with Disabilities Act (ADA) and its twenty year existence and anniversary. He discussed specific policy and titles inherent to the ADA. He discussed construction allowed by the ADA. Ms Rowe discussed how the ADA made differences in people's lives. She introduced the presentation and David Miller, ADA Consultant. Mr. Miller provided a video for Councilors to watch and gave a brief summary of the ADA and its importance for Americans with disabilities. Councilor Harrington provided thoughts on the 20th Anniversary of the ADA. She said it was important to forge ahead and involve all community members in regional events and dialogue. Councilor Burkholder asked about transportation issues for individuals with disabilities.

Burkholder, Hosticka and Liberty voted in support of the motion. The
vote was 6 aye, the motion passed.
