MINUTES OF THE METRO COUNCIL MEETING

Council President David Bragdon convened the Regular Council Meeting at 2:00 p.m.

1. INTRODUCTIONS

President Bragdon welcomed students from a Portland Community College (PCC) Political Science class.

2. CITIZEN COMMUNICATIONS

Darla Sturdy, Gresham; provided testimony on her son's death at a MAX line crosswalk. She provided testimony for the record (see attachments). She discussed safety standards and her experience lobbying elected officials. Councilor Collette asked about safety task forces.

John Charles, Portland, President and CEO of the Cascade Policy Institute; provided testimony on the financial condition of TriMet. He provided testimony for the record (see attachments). Councilor Collette asked about employee classifications. Councilor Liberty asked about payroll taxes.

3. CONSENT AGENDA

3.1 Consideration of minutes for the July 22, 2010 Regular Council Meeting.

Motion:	Councilor Collette moved to adopt the meeting minutes of the July 22, 2010 Regular Metro Council meeting.
Vote:	Council President Bragdon and Councilors Liberty, Harrington, Hosticka, Park, Collette and Burkholder voted in support of the motion. The vote was 7 aye, the motion passed.

4.1 **Ordinance No. 10-1245,** Amending the FY 2010-11 Budget and Appropriations Schedule to Add 1.0 FTE for a Records and Information Analyst to Support the Oregon Zoo's Veterinary Division and Satisfy the AZA Accreditation Requirements, and Declaring an Emergency

Council President Bragdon assigned Ordinance No. 10-1245 to the August 12, 2010 regular Council meeting agenda for second reading and a vote.

5. **RESOLUTIONS**

5.1 **Resolution No. 10-4173,** Authorizing the Chief Operating Officer to Purchase a Quitclaim and Release of Certain Real Property Interests, Partly In Exchange For Real Property Owned By Metro, in the Springwater Corridor Target Area

Motion:	Councilor Liberty moved to adopt Resolution No. 10-4173.
Seconded:	Councilor Collette seconded the motion

Councilor Liberty introduced the resolution and described history of trail segments and development. He discussed geographic location and property acquisition specifics. He said a complete trail was the ultimate vision. President Bragdon thanked staff for their work in a difficult transaction. Councilor Burkholder noted that Council had previously discussed this acquisition.

Vote:

Council President Bragdon and Councilors Burkholder, Harrington, Hosticka, Park, Collette and Liberty voted in support of the motion. The vote was 7 aye, the motion passed.

6. CONTRACT REVIEW BOARD

6.1 Deliberation on Appeal by Hattenhauer Energy Co., LLC of Chief Operating Officer's Rejection of Initial Appeal Regarding Award of Contract for the Provision of Diesel Fuel for Solid Waste Transport Operations under Metro RFB No. 10-1564.

Hattenhauer Energy Co. LLC provided testimony regarding Metro bidding processes. Mr. Hattenhauer provided materials for the record (see attachments). He described his appeal and complaints regarding Metro's bidding processes.

Darin Matthews, Metro Procurement Officer, and Paul Ehinger, Senior Metro Planning Manager, provided a rebuttal to Hattenhauer Energy's appeal. He described the process and reasoning for Metro's current processes. He discussed contract specifics and current review actions.

Mr. Hattenhauer presented his argument regarding current bidding actions. He discussed audits and questioned the lack thereof.

Councilor Liberty asked how conditions worked. Marvin Fjordbeck, Metro Senior Attorney, described obligations and processes. Councilor Hosticka asked about contract specifics and performance measures. Councilor Liberty asked about Mr. Hattenhauer's concerns with Metro's current contractor. Councilor Park asked about substantially complying with bidding requirements.

- Councilor Harrington motioned to deny Mr. Hattenhauer's appeal.
- Councilor Park seconded the motion.

Councilor Collette described her reasoning for supporting Councilor Harrington's motion to deny the appeal. President Bragdon said the Council would appreciate audit issues and

The motion to deny the appeal passed 6-1 (Councilor Burkholder opposed).
