CONSIDERATION OF RESOLUTION NO. 85-571, STATING POLICIES RELATING TO ALTERNATIVE METHODS OF SOLID WASTE DISPOSAL AND SITING OF A GENERAL PURPOSE LANDFILL

### FACTUAL BACKGROUND AND ANALYSIS

The purpose of this resolution is to clarify Metro's position on two elements of the solid waste disposal system. The resolution is in response to questions raised in discussions at the Legislature on the emergency siting legislation. Concern has been raised that Metro's support of such legislation is to facilitate approval of a specific site. This resolution is intended to show that Metro's interest is in finding a site for a general purpose landfill and having a process to bring about a decision on a landfill site. It also shows that Metro is interested in exploring alternative methods of waste disposal to minimize reliance on landfilling.

The resolution addresses two elements of a disposal system -- alternative methods of disposal and landfilling. It states that the Metro Council is in the process of updating the Solid Waste Management Plan and in so doing will:

- 1. Develop a process to "cooperatively respond to and, if feasible, implement alternative waste disposal proposals,"; and
- 2. Recognize the need for a general purpose landfill and will "continue to cooperatively plan for and seek a general purpose landfill site."

As indicated in Exhibit "A" attached, the Solid Waste Management Plan review is underway. Two chapters -- Landfill and Transfer Stations -- have reached the preliminary plan stage; that is, they have been reviewed by the Council and interim policies have been adopted by the Council. The third chapter -- Alternative Technologies -- has been drafted and will shortly be released for "technical" review by interested parties. Council review of this chapter will likely commence in the summer months.

As indicated, the Council has adopted several resolutions setting forth interim policies regarding elements of the Solid Waste Management Plan. These resolutions are attached as follows:

Resolution No. 84-591, for the purpose of adopting an interim management strategy for the St. Johns Landfill Resolution No. 84-506, for the purpose of adopting solid waste transfer station strate-Exhibit "C" gies and related policies as a component of the Solid Waste Management Plan update Exhibit "D" Resolution No. 84-507, for the purpose of adopting long-term landfill strategies as a component of the Solid Waste Management Plan update

Exhibit "E" Resolution No. 85-538, for the purpose of amending Resolution No. 84-491 to add a waste reduction policy to the interim management strategy for the St. Johns Landfill

There appears to be no inconsistencies between Resolution No. 85-571 and the earlier resolutions.

WHEREAS, The Council of the Metropolitan Service District has identified the site known as "Wildwood" to be the next general purpose sanitary landfill when the St. Johns Sanitary Landfill is filled to its design capacity; and

WHEREAS, Due to delays encountered in receiving final approval for the use of Wildwood as the region's next general purpose landfill, it now appears that Wildwood will not be available upon the anticipated closure of the St. Johns Landfill; and

whereas, The Metro Council recognizes the need to ensure uninterrupted access to an environmentally sound and conveniently located general purpose sanitary landfill as a manner of acceptable public health practices; now, therefore,

BE IT RESOLVED,

That the following interim management policies and strategies for the St. Johns Landfill are adopted for the purpose of extending the useful life of this limited resource in order to provide Metro additional time to secure final approval from appropriate governmental bodies for the Wildwood Sanitary Landfill site.

- Metro will attempt to divert additional drop box material to limited use landfills based upon discussions with and suggestions made by the Solid Waste Policy Alternatives Committee (SWPAC).
- 2. Metro will begin to explore and secure permission from other authorized sites accessible to the Metro region for the disposal of municipal solid waste. The Executive Officer will report to the Metro Council on the progress of these discussions at the Council's first regularly scheduled meeting in February of 1985.
- Department of Environmental Quality and the residents of north Portland to develop a process of assessing future development of the St. Johns Landfill to correspond with the opening of the next general purpose regional landfill.

- 1. Metro will own and operate three transfer stations in the Portland metropolitan area. Field operation contracts will be awarded to private companies based upon a competitive bid process. These stations are as follows:
  - a. The Clackamas Transfer & Recycling Center

    (CTRC) located in Oregon City and operational

    since April 1983.

- b. The Washington Transfer & Recycling Center (WTRC) to be located in eastern Washington County and expected to become operational in 1986.
- c. A third station in the City of Portland to become operational upon closure of the St. Johns Landfill. Site evaluation for this facility will commence no later than January 1987.
- 2. Metro transfer stations will be designed to allow removal of appropriate recyclable materials, including source separated materials, and will incorporate strategies to provide the opportunity for future waste processing for recovery of recyclable materials.
- 3. Metro transfer stations will be sited, designed and operated to serve both the commercial collection industry and the general public.
- 4. Additional transfer stations will be franchised on the basis of the number of adequate sites available, economic viability of specific sites, and impact on other elements of the solid waste disposal system.

WHEREAS, The ORS chapters 268 and 459 provide for the development of a solid waste management plan; and

WHEREAS, The Metropolitan Service District (Metro) is the primary provider of the solid waste disposal system in the Portland metropolitan area; and

WHEREAS, The Metro Solid Waste Management Plan was adopted in 1974-75 and as a result of changing practices and policies in the solid waste management field, is due for a comprehensive evaluation and update; now, therefore,

BE IT RESOLVED.

That the following long-term landfill strategies and related policies are adopted for the purpose of clearly indicating the direction the Metro Council intends to proceed as they relate to solid waste management in the Portland metropolitan area:

- 1. The site known as "Wildwood" has been identified and designated by the Metro Council as the long-term regional landfill for the Portland metropolitan area. Metro will continue to pursue siting approval and the required permits which will enable this site to function as an operating landfill.
- 2. Metro recognizes that numerous limited-use landfills have reached capacity and will continue to be less available as current sites are closed. Metro has identified and

supports the development of the site known as "Waybo/Roselawn" as a replacement, limited use landfill for the Killingsworth Fast Disposal site upon its closure which is expected in 1989.

- 3. Metro will continue to rely on the private sector to provide limited use landfills in the region as per conditions stated in Chapter 5.01 of the Metro Code. Each application will be judged on the following criteria in conjunction with the applicant's obtaining appropriate local and state permits:
  - a. A potential site will be evaluated according to its proximity to existing and future landfill sites to ensure the efficiency of the solid waste system;
  - b. Adequate quantities of acceptable waste material should be available to ensure the economic viability of a given site; and
  - c. A proposed site should be consistent with other elements of the solid waste disposal system, including general purpose landfills, transfer stations, recycling efforts, or resource recovery facilities.
- 4. Metro will consider a contractual commitment of solid waste to non-Metro disposal sites or facilities based upon:
  - a. The site(s) or facility(ies) being properly permitted and approved by required governmental bodies;
  - b. The disposal cost available from a site or facility including the financial impact on

Metro operations and subsequent effect on customer costs; and

c. The length of contract term and its concomitant impact on the Metro solid waste disposal system.

- 4. Metro will pursue a reduction in the quantity of waste being landfilled through the development and implementation of additional waste reduction efforts:
  - A comprehensive, coordinated, multi-year regional promotion/marketing plan to be developed by July 1985 and to begin implementation by October 1985.
  - A demonstration project for recycling collection from multiple family dwellings to be completed by June 1986.

Waive collection of user fees and regional transfer charges on mixed waste received at franchised mixed waste sorting operations.

Councilor Gardner agreed with the Executive Officer's recommendation, stating the Resolution could help remove any mistrust that might exist about Metro's intentions for supporting SB 662. He found it difficult to perceive, however, that Metro's support of the bill could be interpreted as a device for siting a landfill at Wildwood.

### 10. COMMITTEE REPORTS

Multnomah County Solid Waste Task Force. Councilor Gardner reported the Task Force was currently reviewing proposals for alternative waste disposal methods. The Task Force would then prepare recommendations for landfill siting criteria, the siting process and alternative technologies. He also reported the Task Force was unable to take a consensus position on SB 662.

Committee for Accessible Transportation. Councilor Kelley distributed an interim report prepared by the Committee. She said Metro's transportation role would be stronger in the new fiscal year and the need for someone to provide a plan for accessible transportation would be very important. She urged Councilors to read the report with this in mind.

Convention Center Task Force. Presiding Officer Bonner said the Task Force had established an ambitious schedule for meetings leading up a decision about the type of facility that should be funded. That decision would be made in July and the public would be asked to vote on funding the facility in May or November of 1986, he said.

There being no further business, Presiding Officer Bonner adjourned the meeting at 7:30 p.m.
