1. INTRODUCTION

Council briefly discussed Resolution No. 11-4229, adopted Jan. 20, which outlines councilor committee assignments for 2011. Council agreed that the assignments will need to be revisited after the current District 6 councilor vacancy is filled. Additional discussion included adding the Local Officials Advisory Committee (LOAC) to the list of committees requesting a Council representative.

Mr. Michael Jordan of Metro briefly overviewed each of the project stewardship and policy projects. Councilors tentatively expressed interest in serving as project lead or liaison for the set of 13 Council projects areas.

4. COUNCIL 2011 TIMELINE

Mr. Jordan briefly overviewed the draft 2011 timeline for projects requiring Council discussion, direction and/or action. Highlights include reserves, greenhouse gas scenarios, Columbia River Crossing Land Use Final Order (CRC LUFO), and urban growth boundary. (The draft 2011 timeline has been included as part of the meeting record.)

5. PLANNING DEPARTMENT WORK PLAN

Ms. Robin McArthur of Metro provided a brief presentation on the Making the Greatest Place initiative's six desired outcomes, principal reports (i.e. state of the centers report and regional infrastructure analysis), and projects (i.e. reserves, infrastructure, and updated regional policies/code language.)

6. MPAC/JPACT DISCUSSION

Unlike previous years, there are no outstanding legislative-driven decisions for the Metro Policy Advisory Committee (MPAC) and Joint Policy Advisory Committee on Transportation (JPACT) in 2011. Ms. McArthur solicited Council direction on how and what to engage the land use and transportation policy committees on for 2011.

General committee discussion included:

- How to better engage MPAC (i.e. Mayors' Institute, Get Centered!, mayors and chairs forum, hosting meetings around the region)
- Committees' membership
- Improved meeting management (i.e. increased time for committee discussion and limiting the length of staff presentations and eliciting discussion)
- Increased integration between MPAC and JPACT (i.e. one verses two committees)
- Support from the technical advisory committees
- Outstanding 2011 MPAC discussion topics (i.e. brownfields, number of centers, land assembly and parcelization, equity).

7. METRO COMPASS

Mr. Jim Middaugh of Metro distributed the Metro Compass, an internal Metro publication tool designed to help staff articulate and identify with the agency's mission, vision and passions.
