

#### METRO COUNCIL MEETING

Meeting Summary March 3, 2011 Metro Council Chambers

<u>Councilors Present</u>: Deputy Council President Carl Hosticka and Councilors Shirley Craddick,

Deputy Council President Carl Hosticka convened the regular Council meeting at 2 p.m.

### 1. <u>INTRODUCTIONS</u>

## 2. CITIZEN COMMUNICATIONS

<u>Ieff Stuhr, 110 SE 8<sup>th</sup> Ave., Portland</u>: Mr. Stuhr addressed the Council on the Columbia River Crossing project; he provided a brief family anecdote that emphasized the need for a bridge that helps define, inspire and enhance the beauty of the region and surrounding area. (Written testimony included as part of the meeting record.)

<u>Walter Valenta, 1441 N. Marine Drive, Portland</u>: Mr. Valenta addressed the Council on the CRC project. He emphasized the importance of the bridge and encouraged the region to move forward quickly. He supported the cable-stay bridge; citing broad community buy-in and support for the bridge alternative, the bridge's artistry, and potential positive impacts to the tourism industry as reasoning.

Council discussion included the projected build timelines and costs associated with the cable-stay and Deck Truss bridge alternatives, examples of infrastructure that were built during the Depression (i.e. Timberline lodge), and the City of Vancouver's support for the bridge alternatives.

### 4. **RESOLUTIONS**

4.1 **Resolution No. 11-4238**, For the Purpose of Approving the Expo Center Conditional Use Master Plan.

Motion:	Councilor Burkholder moved to adopt Resolution No. 11-4238.
Second:	Councilor Carlotta Collette seconded the motion.

Councilor Burkholder introduced Resolution No. 11-4238, which if adopted, would approve the submittal of the updated Expo Center Conditional Use Master Plan to City of Portland. The Expo property is zoned industrial for conditional use and requires updates to plan every 10 years. Councilor Burkholder highlighted storm water management and transportation management as two major elements that needed to be addressed through the updated proposal. The proposal is due to the City by June 2011 when the current master plan expires.

Vote:

Deputy Council President Hosticka and Councilors Harrington, Craddick, Collette, Roberts, and Burkholder voted in support of the motion. The vote was 6 aye, the motion <u>passed</u>.

## 5. <u>CHIEF OPERATING OFFICER COMMUNICATION</u>

Mr. Michael Jordan of Metro reminded the Council that the March 8 work session has been canceled. Additional updates included Metro's upcoming household travel demand survey.

Mr. Marv Fjordbeck, Office of the Metro Attorney, briefly overviewed the Metro Council redistricting process, state and Metro Charter requirements, and timeline. The Council must complete the redistricting process by May 23, 2011. Staff will schedule time at an upcoming work session for further discussion. Council discussion included establishing a subset of the council to serve as a "redistricting committee," selecting/defining communities of interest, and the date new districts take effect.

#### 6. <u>COUNCILOR COMMUNICATION</u>

Council discussion included updates on the recent JPACT, MER Commission, and Lake Oswego to Portland Transit Steering Committee meetings, the Oregon legislature, and outreach in councilors' districts.
