FACTUAL BACKGROUND AND ANALYSIS

As part of the budget review process, the Council will appoint seven citizens to the Budget Committee (five new appointments and two reappointments). The purpose of the Committee is to review the proposed FY 1987-88 Metro budget and make recommendations to the full Metro Council.

A news release was sent to several newspapers and radio stations in the region seeking citizens to serve on the Budget Committee. Articles appeared in three newspapers. A total of 11 citizens expressed interest in serving on the Budget Committee. A list of these individuals is attached.

In an effort to have broad, balanced representation on the Committee, constituency groups, experience, ethnic and sex makeup of the group was considered. The following citizens are recommended for appointment: Michael Burns (reappointment), Becky Charles (reappointment), Linda Girard, Ron Hohnstein, David Little, John Michelet, and Oladapo Sobomehin.

The recommended group includes three representatives from the east side of the District and four representatives from the west side; two minorities, two women and a representative of the solid waste industry.
