WHEREAS, The voters of the District approved on November 4, 1986, \$65 million in General Obligation bonds to fund the construction of the Oregon Convention Center; and

WHEREAS, The Oregon Convention Center is seen in the community as a visible sign of the region's energy, vitality, and confidence in its economic future, making construction of the Center on-time and in-budget of critical importance; and

WHEREAS, The Oregon Convention Center project was concieved and planned with the cooperation and vision of the region's governments and community leaders; and

WHEREAS, The continued involvement of community members with experience and foresight is desirable for a complex public construction project; and

WHEREAS, In its approval of the convention center site at Holladay and Union Streets, the Portland City Council through Ordinance No. 158553 requires that the Metropolitan Service District appoint "...a regional committee to solicit public input and to advise on the design and construction of the Center..."; and

WHEREAS, The Executive Officer established in May of 1986 a committee to advise in the organization and direction of the project; and WHEREAS, This Advisory Committee has continued to provide valuable advice to the Project Director; and

WHEREAS, The Metro Council Convention Center Committee unanimously supports confirmation of the Advisory Committee on Design and Construction by the Metro Council; now, therefore,

BE IT RESOLVED,

1. That an Advisory Committee on Design and Construction of the convention center is hereby confirmed to provide advice and assistance to the Convention Center Project Director during the construction of the Oregon Convention Center.

2. That the Advisory Committee shall have seven to ten members appointed by the Executive Officer, serving at her pleasure, and shall include representatives from the Council of the Metropolitan Service District, the City of Portland Exposition-Recreation Commission, community members instrumental in the planning and promotion of the project, and citizens experienced in the design and construction of large projects.

- 3. That duties of the Committee shall include:
  - a. Recommend to the Project Director key consultants for the project;
  - Recommend to the Project Director a program to solicit public comment and review of the project's design and construction, and to oversee this program's implementation;
  - c. Hold hearings as requested and provide advice and assistance through the completion of the City of Portland design review process, as required by Portland Ordinance No. 158553; and
  - d. Provide advice and assistance to the Project Director during the course of construction.

4. That the Advisory Committee shall terminate upon construction of the Oregon Convention Center project.

# FACTUAL BACKGROUND AND ANALYSIS

The Advisory Committee on Design and Construction was initially established by the Executive Officer in May 1986 to advise the Executive Officer and Project Director regarding design and construction of the convention center project.

The Council's Convention Center Committee recommends the formal confirmation of the Committee by the Metro Council since advice from this advisory committee will be instrumental in decisions made by Council. This action will also enable the Advisory Committee to serve the purposes set forth in the City of Portland Ordinance of May 28, 1986, approving the site and outlining the Center's planning and design review requirements. Specifically, the City Ordinance requires Metro to appoint "...a regional committee to solicit public input and to advise on the design and construction of the center...."






