Implementing the Community Investment Strategy

Metro's Planning and Development Department provides leadership in advancing and implementing the regional vision and 2040 Growth Concept. Our work leads to tangible changes to the built and natural environment through targeted infrastructure investment and through the creation of conditions that stimulate development. We partner with citizens, advocacy groups, the private sector, and other governments and agencies in recognition of the shared role we all have in achieving the vision.



Core Programs

Work directly related to Metro's role as the federally designated Metropolitan Planning Organization (MPO), ongoing state requirements, and Metro's charter, Framework Plan and Functional Plan.

Examples:

- Compliance work on local comprehensive plan updates and zoning amendments
- Regional Transportation Plan updates, review of local Transportation System Plans
- 2040 performance reporting
- Administration and periodic review of Urban Growth Boundary
- Metropolitan Transportation improvement Program and Regional Flexible Funding
- Concept planning of new urban areas and urban reserves

Regional Collaborative Initiatives

Major multi-jurisdictional projects to advance the regional vision and local implementation.

Examples:

- Climate Smart Communities scenarios (+)
- SW Corridor Plan
- Lake Oswego to Portland Transit
- Next corridor (Powell/Division Bus Rapid Transit?)

Implementation Tools

Developing and sharing tools and innovative solutions that support local implementation of the 2040 Growth Concept and create conditions that stimulate development.

Examples:

- Large lot industrial sites inventory and action plan
- · Coordination with Greater Portland Inc. on economic development
- Transportation System Management and Operations program
- Freight Plan implementation
- Station area planning
- Downtown revitalization and redevelopment (Development Opportunity Fund)
