FACTUAL BACKGROUND AND ANALYSIS

Resolution No. 87-785-A was adopted July 23, 1987, for the purpose of initiating an update of the regional Solid Waste Management Plan. It established a Policy Committee and a Technical Committee to advise the Council on the development of the Plan.

At the joint meeting of the Council Solid Waste Committee and the Solid Waste Policy Advisory Committee (SWPAC) held August 11, 1987, there was discussion regarding the duplication of purpose and representation of the new Technical and Policy Committees and the SWPAC. Because of the duplication it was suggested that SWPAC be abolished.

On August 25, 1987, the Council Solid Waste Committee discussed the duplication of efforts between the SWPAC and the new Technical Committee and voted to recommend to Council that the SWPAC be abolished. On August 26 the SWPAC voluntarily dissolved itself by a unanimouss vote of the Committee members (see attached letter from Committee Chair Kathleen Cancilla).

Adoption of Resolution No. 87-804 would abolish Metro's Solid Waste Policy Advisory Committee (SWPAC).
