CONSIDERATION OF RESOLUTION NO. 87-813 FOR THE PURPOSE OF RECOGNIZING RECYCLING ACHIEVEMENT IN THE METRO REGION

Date: September 24, 1987

Awards presented by Executive Officer Cusma and Presiding Officer Waker.

Proposed Action

To present two recycling recognition awards. One to the City of Portland and one to Grimm's Fuel Company.

Factual Background and Analysis

In FY 86/87 during Recycling Awareness Week, Metro presented Recycling Recognition Awards to Clackamas County and the Clackamas County Haulers Association. The awards were given to the two groups for:

- a. innovative approaches to funding recycling promotion and and education programs
- b. exemplary performance carrying out the curbside recycling service
- c. having a direct impact on the amount of recycling and quality of recycling in the Metro area
- d. had not received recognition from Metro in previous years

As part of Recycling Awareness Week this year, I recommend we once again recognize recycling achievements in the Metro area. The awards can be given to private citizens, businesses, non-profit and/or government agencies.

Public Affairs and the Solid Waste department recommend the City of Portland and Grimm's Fuel Company as the recipients of the Recycling Recognition Awards.

Explanation of Nominations

The City of Portland

The City of Portland, though late in implementing the curbside recycling service, showed a very innovative approach in promoting the new service. The "Yes We Can Can" theme was positive, up-beat, and created a sense of goodwill between private industry and government.

The City went beyond the "Normal" scope of work in promoting the service. The City has not been previously recognized by Metro for recycling contributions.

Grimm's Fuel Company

Grimm's Fuel Company has worked closely with Metro over the past six years in developing their yard debris processing facility. Six years ago, Grimm's received a small research and development grant from Metro. Since then, the company has spent thousands of dollars developing the processing facility.

Grimm's has had a direct impact on reducing the amount of yard debris going to regional landfills. The national average of yard debris in the waste stream is 18 percent. In the Portland Metro area the average is 10 percent. Grimm's has helped make this possible. Metro has not previously recognized Grimms for their recycling contributions.
