WHEREAS, No responsive bids were received for cone mix; and

WHEREAS, Based upon the lack of bids, it appears that the current vendors, Metro Sweden Freezer Sales, is the only qualified provider of this item and that this vendor should be considered a sole source; and

WHEREAS, The Zoo Committee recommends approval of the contract; now, therefore,

BE IT RESOLVED,

1. That the Council of the Metropolitan Service District authorizes the District to enter into a contract with Metro Sweden Freezer Sales within five (5) days of the adoption of the Resolution.

2. That the contract be in effect for a period of one year from the effective date of the contract.

# Memorandum

Regarding: RESOLUTION NOS. 88-856 AND 88-857 REGARDING FOODSTUFF FOR THE ZOO

The purpose of this memo is to point out necessary changes to Resolution Nos. 88-856 and 88-857 for foodstuffs for the Washington Park Zoo.

On February 4, 1988, the Council Zoo Committee recommended Council approval of several resolutions authorizing the District to enter into contracts for various foodstuff. Included in those resolutions were Resolution Nos. 88-856 and 88-857. These two resolutions inadvertently included the same phrase as all the other resolutions: "...has been found to be the lowest responsive, responsible bidder for the items on the proposed contract...."

Resolution Nos. 88-856 and 88-857 has been revised to state:

WHEREAS, No responsive bids were received for popcorn items or fruit whip; and WHEREAS, Based upon the lack of bids, it appears that the current vendors, Poppers Supply, is the only qualified provider of these items and that this vendor should be considered a sole source..."

Resolution No. 88-857 has been amended to read:

"WHEREAS, No responsive bids were received for cone mix; and WHEREAS, Based upon the lack of bids, it appears that the current vendors, Metro Sweden Freezer Sales, is the only qualified provider of this item and that this vendor should be considered a sole source...."
