STAFF REPORT

RESOLUTION NO. 88-873, PROPOSAL FOR CONSIDERATION OF A RESOLUTION FOR THE PURPOSE OF NAMING THE ZOO'S AFRICAN AVIARY IN HONOR OF HOWARD VOLLUM

DATE: 4 February 1988 PRESENTED BY: Ellen Lanier Phelps

Factual Background and Analysis

In June, 1988, construction of the African Aviary at the Zoo will be completed. The glass structure has been designed to encompass tropical plantings, a running stream and pedestrian pathways. Numerous exciting and colorful African bird species will be housed there, to be enjoyed by zoo visitors in the only walk-through aviary of its kind in the metropolitan area. The birds and vegetation will be afforded the chance to settle in for several months before pathways are actually open to the public, but their exotic colors and habits will be visible in this unique setting through windows in the AfriCafe from June on.

When Howard Vollum died in February, 1986, he left a request that one-half of one percent (.5%) of his estate go to benefit the Washington Park Zoo. At this time, the value of that bequest approaches \$400,000. Because Mr. Vollum left no guidelines to the Zoo on the expenditure of those funds, staff has met with Mrs. Vollum to seek her input and guidance for an appropriate manner to use his gift. Staff provided Mrs. Vollum information on all imminent zoo projects. In response, she has indicated that she feels the aviary, with its myriad of bird species and prominent role in zoo growth and development, would be a wonderful tribute to her husband.

Staff recommends the Council consider recognition of this major gift from Howard Vollum's estate by designating the African aviary the Howard Vollum Aviary. Staff makes this recommendation not only for Mr. Vollum's thoughtful gift but also for the generosity and love shown the Zoo over many years. Mr. Vollum spent many hours with his children on zoo grounds; in addition, his and Mrs. Vollum's commitment to our community and its enrichment have led to the placement of artwork by Northwest artists in several areas around the Zoo. Mrs. Vollum has requested that, should the Council accept this staff recommendation, the Howard Vollum Aviary name acknowledgement be displayed in a discreet manner.

WHEREAS, From time to time the Council may find it appropriate to name Metropolitan Service District (Metro) facilities, such as major exhibits and public spaces, in honor of individuals; and

WHEREAS, Providing such recognition to individuals who make substantial contributions to Metro's programs or facilities is an important part of the fundraising process; now, therefore,

BE IT RESOLVED.

- 1. That the Council of the Metropolitan Service District observe the following criteria in naming exhibits and public spaces in honor of individuals:
- a. The overriding consideration in providing such recognition shall be the individual's substantial or sustaining effort to improve the quality of Metro or Metro services which may include, but shall not be limited to:
 - Donations of funds;
 - 2) Donations of time and talent; and
 - 3) Provision of other services such as leadership roles in organizations which work directly toward improving the quality of Metro.
- b. The nature and magnitude of this recognition shall be proportional to the magnitude of contributed gifts or services.
- c. Recommendations for this type of recognition shall be initiated by the appropriate Department Head in cooperation with

the Executive Officer and the Metro Council shall have the sole authority to approve such recommendations.

- 2. That the Metro Council observe the following guidelines in naming exhibits and public spaces in honor of individuals:
- a. Recognitions appearing on Metro property shall be in a format consistent with established graphic standards;
- b. Staff designated by the Executive Officer shall participate in the design of the memorialization in order to provide maximum coordinating with current or subsequent and continuing recognitions; and
- c. Recognition devices, plaques or ornaments shall be consistent with the architectural statement and shall be in context with the visual appeal of the building in or on which the device, plaque or ornament shall be placed.

8.2 Consideration of Ordinance No. 88-240A, Adopting an Updated Solid Waste Management Plan (Second Reading)

Councilor Hansen, Chair of the Solid Waste Committee, reported the ordinance amended the Management Plan to exclude reference of the formerly designated Wildwood landfill. After conducting a public hearing, the Committee unanimouly recommended adoption of the ordinance.
