Dear Ted,

We have reviewed the chronology of consolidation issues prepared by Chris Thomas for the City of Portland. The events and communications described in the chronology create the impression that MERC has been relieved of its charge from the Council to lead the consolidation effort. We are writing to assure you that the policy of Metro, as stated in the Code provisions which establish MERC, is that the MERC is responsible for making recommendations to the Council on consolidation issues for Council approval.

The ordinance is very specific:

"6.01.090 Initial Charge to Commission: Following appointment of its members and during the time prior to the completion of construction of the convention center, the Commission shall do the following . . .

(b) Not later than September 1, 1988, report to the Council on the progress of, and make recommendations to the Council of appropriate action regarding negotiations with local governments within the district for the transfer of appropriate facilities or operations to the Commission. The negotiations may include but are not limited to the transfer of assets and liabilities and operational responsibilities; transfer of employees; revenue and expenditure requirements; and schedules and charges and methods of determining charges."

The Executive Officer's statements, including some we had no knowledge of, may have left the impression that MERC had been relieved of the responsibility set forth in Section 6.01.090. The Council has not acted to

> rescind or amend this or any other provision of the MERC Code. Although the September 1, 1988, date has passed, consolidation remains a matter of the highest priority for the Council, and we urge the Commission to take an active role in making it happen.

To assist the Commission with its consolidation responsibility, the Council has appointed a task force consisting of Presiding Officer Ragsdale, Executive Officer Cusma, Councilor Knowles, Tom Walsh and you. The task force will assist MERC and its staff with the preparation of the recommendations and will guide the negotiations with other jurisdictions.
