RELATING TO THE REQUEST BY THE CITIES OF TUALATIN AND SHERWOOD TO EXTEND THE TIME FOR PLANNING UNDER TITLE 11 OF THE URBAN GROWTH MANAGEMENT FUNCTIONAL PLAN FOR THE AREA KNOWN AS AREA 61

WHEREAS, on June 29, 2012, the Cities of Tualatin and Sherwood requested an extension of time to complete concept planning required by Title 11 of the Urban Growth Management Functional Plan (UGMFP) for the area known as Area 61; and

WHEREAS, Metro Code Section No. 3.07.830 establishes a process and criteria for extension of time for compliance with a requirement of the UGMFP; and

WHEREAS, Section 3.07.830 authorizes the Chief Operating Officer (COO) to grant an extension if the COO finds either that the Cities of Tualatin and Sherwood are making progress toward completion of Title 11 planning or that there is good cause for the cities' inability to meet the completion for planning; and

WHEREAS, the COO provided notice of the proposed extension pursuant to Metro Code Section No 3.07.830A; and

WHEREAS, the COO has not granted a previous extension of time for completion of Title 1 planning for Area 61; and

WHEREAS, the Metro Planning & Development Department has reviewed the application and recommends approval; and

WHEREAS, the COO finds, based upon the written recommendation of the Planning & Development Department, that the cities are making progress by transferring concept planning responsibility for Area 61 to the City of Sherwood, which will be completed concurrently with concept planning on Urban Reserve Area 5A, now, therefore

IT IS HEREBY ORDERED THAT:

- 1. The request of the Cities of Tualatin and Sherwood for an extension of time under Metro Code 3.07.830 to complete concept planning for Area 61 pursuant to Title 11 of the UGMFP is approved under the terms and conditions set forth in Section 2 of this Order.
- 2. The deadline for compliance with Title 11 for the City of Sherwood for Area 61 is extended to coincide with completion of concept planning for Urban Reserve Area 5A under Metro Code Section No. 3.07.1110, or to December 31, 2021, whichever comes earlier.

Thank you for your request regarding Concept Planning for Area 61 dated June 29, 2012 and for working jointly with the City of Tualatin to address this outstanding issue.
