#### STAFF REPORT

IN CONSIDERATION OF RESOLUTION NO. 03-3384, FOR THE PURPOSE OF APPOINTING CITIZEN MEMBERS TO THE TRANSPORTATION POLICY ALTERNATIVES COMMITTEE (TPAC) IN NOVEMBER 2003

### **BACKGROUND**

Three of six citizen positions on TPAC will expire in November 2003. Potential candidates were selected from applications received during the November 2002 solicitation to fill citizen terms on TPAC. Potential candidates were also selected from applications solicited in spring 2003 for the Hwy. 217 Policy Advisory Committee. In both cases, the recruitments had extensive public notification processes, including advertisements in newspapers, post card notices, web page information and transportation hotline messages. In all, 28 letters were sent to potential candidates and 15 replies of interest were received for the TPAC positions. A total of seven citizens were interviewed by the Nomination Committee, which consisted of Councilor Rod Park, and staff members Mark Turpel and Marilyn Matteson.

### **EXISTING LAW**

Metro Code [reference Ordinance No. 00-860A Section 2.19.003 (a) and (b) (6)] states that citizen representatives be nominated through a public application process, confirmed by the Metro Council and appointed by the Presiding Officer of the Metro Council. Citizen members serve for two years upon appointment. Citizen members are limited to two consecutive 2-year terms.

### RECOMMENDED ACTION
