FACTUAL BACKGROUND AND ANALYSIS

During December, notice of the six TPAC citizen positions was circulated through the Oregonian and Skanner and through mailings to Councilors, JPACT, TPAC and local governments. On January 9, the Intergovernmental Relations Committee reviewed a list of 25 possible applicants (Attachment A) and appointed a subcommittee to develop a recommendation to the full committee. The subcommittee members were:

Councilor Jim Gardner, Chair Councilor Richard Devlin Andy Cotugno, Transportation Director

The subcommittee screened the 25 applications to narrow down the list to the best candidates with a balance of geographic coverage, a broad range of interest groups and the greatest level of involvement in community activities. Generally, there was an attempt to interview two good candidates for each interest group. The following were selected for interviews:

Cherie McGinnis (Clackamas County)
Ray Polani (Transit advocate)
Jim Klingler (Private transit operator, RAZ)
Raye Woolbright (Private transit operator, cab)
John Godsey (Washington County, civil engineer)
Daniel Howe (S.E. Portland, Portland budget committee)
Mark Fisher (Sunset Corridor Association)
Michael Love (CEIC, Gresham)
Michael Meredith (trucking)
Jack Lindquist (trucking, Clackamas County)
Greg Oldham (S.W. Portland, City Club
Transportation Committee)
Nancy Ponzi (Vintner, Washington County, STOP)
Molly O'Reilly (N.W. Portland, STOP)

Cherie McGinnis withdrew her application before the interview and Jim Klingler failed to make the interview. Based upon the interviews, the subcommittee sought to narrow the field as much as possible while having some key final decisions made by the IGR Committee.

It was concluded by the subcommittee that trucking should be represented and that Jack Lindquist was the best candidate inasmuch as he is on the Oregon Trucking Association board while Mike Meredith is their lobbyist. Similarly, the subcommittee felt that a private transit operator should be represented and is therefore recommending appointment of Raye Woolbright from Broadway Cab. John Godsey is also recommended as a firm appointment to maintain continuity with his previous term on TPAC.

Of the remainder, the following five were considered by the IGR Committee to fill the remaining three seats:

Nancy Ponzi -- previous TPAC member; represents rural interests in Washington County; member of STOP.

Molly O'Reilly -- N.W. Portland representative; active in N.W. Portland neighborhood activities; particularly interested in environmental, land use and transit issues.

Greg Oldham -- principal author of City Club committee report on regional transportation funding resulting in broad exposure to transportation issues; attorney; S.W. Portland resident; particularly interested in environmental and transit issues.

Daniel Howe -- chairman of Portland Transportation Budget Advisory Committee for two years plus member for two additional years; N.W. Natural Gas rate analyst; interested in long range future of LRT and major highways; S.E. Portland resident.

INTERGOVERNMENTAL RELATIONS COMMITTEE REPORT

RESOLUTION NO. 90-1206, CONFIRMING CITIZEN MEMBER APPOINTMENTS TO THE TRANSPORTATION POLICY ALTERNATIVES COMMITTEE (TPAC)

Date: February 14, 1990 Presented By: Councilor Jim Gardner

COMMITTEE RECOMMENDATION: At the February 13, 1990, Intergovernmental Relations Committee meeting, Councilors Devlin, McFarland, Ragsdale and myself were present and voted unanimously to recommend Council adopt Resolution No. 90-1206 as amended, identifying the recommended six citizen appointments. Councilor Bauer was excused.

COMMITTEE DISCUSSION/ISSUES: Resolution No. 90-1206 appoints six citizens for two-year terms on TPAC. The recruitment process began in November 1989, with the announcement of appointment slots, and 25 applications were received. At the January 9 Intergovernmental Relations (IGR) Committee meeting, a selection subcommittee was formed with myself as chair, Councilor Devlin and Metro Transportation Department Director Andy Cotugno participating. The subcommittee interviewed 13 of the 25 applicants and then narrowed the field down to 8 possible appointments. Of the 8 candidates, the subcommittee presented 3 names -- Raye Woolbright, John Godsey, Jack Lindquist -with a firm "do appoint" recommendation. It was noted the subcommittee used three criteria in selecting the recommended appointees: 1) a balance of interest groups; 2) geographic distribution; 3) experience in community involvement or transportation issues. The Committee moved unanimously to adopt the subcommittee's "do appoint" recommendation for Mr. Woolbright, Mr. Godsey and Mr. Lindquist. The Committee agreed to vote to select 3 of the remaining 5 citizens for appointment.

After reviewing the backgrounds of the 5 remaining candidates --Daniel Howe, Greg Oldham, Ray Polani, Nancy Ponzi, Molly O'Reilly --Committee members each voted for 3. This first ballot resulted in 4 votes for Molly O'Reilly, 3 votes for Ray Polani, 2 votes each for Nancy Ponzi and Greg Oldham, and 1 votes for Daniel Howe. Having received a majority of the votes, Ms. O'Reilly and Mr. Polani were recommended for appointment. To determine the final appointee, a second ballot was cast resulting in 2 votes each for Ms. Ponzi and Mr. Oldham and no votes for Mr. Howe, eliminating Mr. Howe as a candidate. The Committee discussed options to proceed, including forwarding the 5 recommended appointments and leaving the sixth appointment between Ms. Ponzi and Mr. Oldham up to a full vote of the Council. Committee members also shared their votes and reasons for supporting either candidate. It was determined inappropriate to call upon the Council to vote on the sixth appointee and it was also felt the final appointment should not be unduly delayed. After more discussion, Councilor Devlin moved unanimous approval of Greg Oldham as the sixth appointee. The Committee voted 4 to 1 on the motion with Councilor McFarland dissenting. On the final vote to recommend Council adoption of the resolution with the 6 appointees -- Woolbright, Godsey, Lindquist, O'Reilly, Polani, Oldham -- the Committee voted unanimously.

Ray Polani -- president of Citizens for Better Transit; transit activist since 1969.

Of those five candidates, the Intergovernmental Relations Committee recommends appointment of:

Molly O'Reilly Greg Oldham Ray Polani
