WHEREAS, The Alliance has successfully implemented a regional tourism strategy benefitting each member jurisdiction and the State of Oregon; and

WHEREAS, The strategy complements the marketing and success of the Oregon Convention Center; and

WHEREAS, Metro appointed Karen Whitman, private citizen, to represent Metro on the Oregon Tourism Alliance Board, together with Councilor David Knowles as alternate.

WHEREAS, Karen Whitman has resigned as of January 22, 1991; and Councilor Knowles has simultaneously removed himself as Metro's alternate to the OTA Board; and

WHEREAS, Metro continues to endorse the concept and work of the Oregon Tourism Alliance and desires to remain a partner to the regional strategies process; and

WHEREAS, Continued representation requires the appointment of a board member and an alternate to serve the remaining portion of the vacated positions; now therefore,

BE IT RESOLVED,

That Pamela Stebbeds Knowles be confirmed as Metro's appointment to represent Metro as a member of the Oregon Tourism Alliance board; and that Don Rocks, Executive Assistant to the Executive Officer, be confirmed as alternate through June 31, 1992.

# REGIONAL FACILITIES COMMITTEE REPORT

RESOLUTION NO. 91-1417, CONFIRMING THE APPOINTMENT OF METRO'S REPRESENTATIVES TO THE OREGON TOURISM ALLIANCE BOARD

<u>COMMITTEE RECOMMENDATION</u>: At its April 9, 1991 meeting, the Regional Facilities Committee voted unanimously to recommend Council adoption of Resolution No. 91-1417. Voting were Councilors Knowles, Bauer, Buchanan, Gardner, and McFarland.

COMMITTEE DISCUSSION/ISSUES: Don Rocks introduced the resolution by explaining that Karen Whitman, Metro's previous representative to the Oregon Tourism Alliance (OTA), resigned effective January 22, 1991. He introduced Pamela Stebbeds Knowles, the Executive Officer's nominee to replace Ms. Whitman, and pointed out that the resolution also names Mr. Rocks as Metro's alternate to the OTA Board, replacing Councilor David Knowles.

Ms. Knowles made a brief statement. She is a lawyer in private practice, with a specialty in hospitality law. She has worked with the Portland/Oregon Visitors Association (POVA), and other tourism groups. She has reviewed the OTA work plan, and is interested in the public/private and public/public partnerships that the OTA is pursuing.

There was no substantive committee discussion, and Councilor Buchanan moved approval of the resolution.

# FACTUAL BACKGROUND AND ANALYSIS

Resolution No. 91-1417 replaces both Karen Whitman as the Metro voting citizen appointment to the Oregon Tourism Alliance Board and Councilor David Knowles as alternate.

Karen Whitman resigned effective January 22, 1991 owing to a business merger and associated demands upon her time. Councilor David Knowles simultaneously stepped down as alternate.

Resolution No. 91-1417 appoints Pamela Stebbeds Knowles to the Oregon Tourism Alliance Board to serve the unexpired portion of Karen Whitman's term. Don Rocks will replace Councilor David Knowles as alternate.
