### IN CONSIDERATION OF RESOLUTION NO. 04-3451 FOR THE PURPOSE OF CONFIRMING THE APPOINTMENT OF SARAH BARRETT TO THE NORTH PORTLAND REHABILITATION AND ENHANCEMENT COMMITTEE (NPREC)

## BACKGROUND

The eight-member North Portland Rehabilitation and Enhancement Committee (NPREC) is charged with making recommendations to the Metro Council regarding policies and the administration of the rehabilitation and enhancement program for the North Portland Area, including recommending projects for funding.

Metro Code 2.19.140(b) authorizes membership on the Committee, including seven citizen neighborhood representatives. The Overlook neighborhood representative position on NPREC is vacant. The Overlook Neighborhood Association Board has forwarded the nomination of Sarah Barrett to the NPREC (see Attachment 1).

During the 2003-04 grant cycle, Ms. Barrett was called on by the Overlook neighborhood association board to complete the NPREC term of the representative from Overlook after he moved from the area. Ms. Barrett performed in an exemplary manner and expressed interest in serving on the Committee (see Attachment 2).

## ANALYSIS/INFORMATION

1. **Known Opposition.** There is no known opposition to the proposed legislation.
2. **Legal Antecedents.** Chapter 2.19 of the Metro Code Relating to Advisory Committees; Section 2.19.140 provides for a North Portland Rehabilitation and Enhancement Committee (NPREC); and Section 2.19.140 authorizes representatives for Committee membership.
3. **Anticipated Effects.** Adoption of this resolution would confirm the appointment of Sarah Barrett to the NPREC.
4. **Budget Impacts.** None.

The Metro Council President recommends adoption of this resolution to confirm the appointment of Sarah Barrett to the NPREC.
