WHEREAS, the voters of the District approved a Metro Charter in the General Election of November 3, 1992 which document establishes a Metro Policy Advisory Committee (MPAC), and;

WHEREAS, the Metro Charter, and Metro Code Section 6.01.030, provides that three citizen members of the Metro Policy Advisory Committee (MPAC) shall be appointed by the Executive Officer and confirmed by the council, and;

WHEREAS, such members shall reside within the District boundaries but may not be an elected officer of or employed by Metro, the state, or a city, county or special district, and;

WHEREAS, it is necessary for the conduct of Metro Policy Advisory Committee (MPAC) business that citizen members representing Metro be named and seated, and;

WHEREAS, two of the three required citizen members were appointed and confirmed by Resolution 93-1742 and the third citizen member has been appointed by the Executive Officer and remains to be confirmed; now, therefore,

BE IT RESOLVED

1. That Sandra Suran, citizen of the District, be confirmed as a member of the Metro Policy Advisory Committee (MPAC):

2. That as a citizen member representing Metro, Sandra Suran shall serve an indefinite term until such time as she may be replaced by a subsequent appointment of the Executive Officer and confirmation by the Metro Council.

GOVERNMENTAL AFFAIRS COMMITTEE REPORT

RESOLUTION NO. 93-1760, CONFIRMING A THIRD CITIZEN MEMBER APPOINTEE TO THE METRO POLICY ADVISORY COMMITTEE

Date: February 19, 1993 Presented by: Councilor Hansen

<u>COMMITTEE RECOMMENDATION</u>: At its February 17, 1993 meeting the Governmental Affairs Committee voted 5-0 to recommend Council adoption of Resolution No. 93-1760. Voting were Councilors Gates, Gardner, Hansen, Moore, and Wyers.

<u>COMMITTEE DISCUSSION/ISSUES</u>: Sandra Suran appeared to testify before the committee. Chair Gates asked if she had ever been convicted of a felony; she has not. Chair Gates then asked Ms. Suran how she perceives the role of MPAC and its relationship to Metro. Ms. Suran said she saw MPAC's role as assisting Metro to be a more effective regional government.

Councilor Moore asked Ms. Suran why she is interested in serving on MPAC, and how she would bring her citizen viewpoint to the committee. Ms. Suran said her citizen role make it important to represent the entire region and not a single geographic area. It will be her job to look beyond individual interests and boundaries in order to make regional government more effective, and encourage others to adopt that broader perspective. Councilor Moore asked how she would represent the views of citizens; what would be her Suran said she understood the value of constituency? Ms. government while being outside government, and she could bring a She cited her experience as a founding member of balanced view. the Tualatin Valley Economic Development Corporation, in which her role was to balance the needs and interests of business and government; her role on MPAC would be similar, but much broader in scope.

Councilor Wyers asked Ms. Suran if she had any business dealings with Metro. She answered that she had done a volunteer project several years ago, but there was no fee involved.

PROPOSED ACTION:

To adopt a resolution naming Sandra Suran to serve as a citizen member of MPAC representing Metro. Council approval constitutes confirmation as required by the Metro Charter and Metro Code Section 6.01.030.

BACKGROUND AND ANALYSIS:

Ms. Suran has been interviewed by the Executive Officer, understands the time commitment and the importance of the MPAC responsibility. The appointee has a history of involvement in public affairs and policy.

Ms. Suran understands that MPAC's first job is one of organizing to conduct business. The Executive Officer has confidence in her ability to make a contribution to this initial phase.

MPAC appointees understand that they have not been appointed for a specific term and may at an unspecified future time be replaced even as the thrust of MPAC's work or the issues under consideration may benefit from specific or additional expertise.

Taken together, the three Metro citizen appointees have been and will be selected with an eye to geographic distribution and balance; not on a formula basis that institutionalizes a requirement that one representative be named from each of the three counties.
