<u>COMMITTEE RECOMMENDATION</u>: At its February 18, 1993 meeting the Governmental Affairs Committee voted 5-0 to recommend Council adoption of Resolution No. 93-1763A. Voting were Councilors Gates, Gardner, Hansen, Moore, and Wyers.

<u>COMMITTEE DISCUSSION/ISSUES</u>: Council Analyst Judy Shioshi presented the staff report. She noted three vacancies had been filled since the committee agenda was printed, and distributed a revised Exhibit A which contained the three names. One vacancy remains to be filled, which will require another resolution.

Councilor Gardner raised an issue with the committee concerning an issue of CCI membership. He said the regular member representing District 3 has requested a leave of absence through July 1. Resolution 93-1763 fills a vacancy in the alternate position for District 3. Councilor Gardner asked whether the committee wanted to appoint the new alternate to fill the regular member position, since the regular member would be expected to miss more than three meetings; CCI by-laws stipulate that unexcused absence from three consecutive meetings may constitute grounds for removal. Councilor Gardner suggested that the CCI consider this question of membership and qualifications. Metro CCI Chair Gail Cerveny supported Councilor Gardner's suggestion, adding that another member has requested a six-month leave of absence. Chair Gates agreed to refer this issue to the CCI.
