BACKGROUND

The 25-member Regional Solid Waste Advisory Committee (SWAC), representing recyclers, the hauling industry, disposal sites, citizen-ratepayers and local governments, evaluates policy options and presents recommendations to the Metro Council regarding regional solid waste management and planning.

The Oregon Department of Environmental Quality (DEQ) representative on SWAC recently left the agency. Her replacement in the role of Manager of Solid Waste Policy & Program Development, Ms. Loretta Pickerell, has been recommended by DEQ as the new representative to Metro's Solid Waste Advisory Committee. 1. Known Opposition

2. Legal Antecedents

ORS 192.610 "Governing Public Meetings", Metro Code Chapter 2.19.030, "Membership of the Advisory Committees" and 2.19.130, "Metro Solid Waste Advisory Committee", are the relevant legal documents related to these appointments.

This resolution is intended to appoint Ms. Loretta Pickerell as the Oregon Department of Environmental Quality's representative, for a two-year term of service on the SWAC.
