

METRO COUNCIL RETREAT

Meeting Minutes January 22, 2015 EXPO Center, Room

Council President Hughes noted a quorum was present and called the council retreat to order at 1:45 p.m.

1. <u>INTRODUCTION AND BACKGROUND</u>

Ms. Martha Bennett provided an overview of the agenda, indicating that the retreat would be split into two areas: identifying key issues for the upcoming budget and confirming strategic areas. Ms. Bennett listed the strategic areas based on previous retreats: infrastructure, innovating planning, natural environment, role in regional economic development/job creation, changing demographics and build increased citizen support.

2. REVIEW MAJOR BUDGET DECISIONS FOR 2015-2016

Mr. Tim Collier provided a brief summary overview of the FY 2014-15 adopted budget compared to the FY 2015-16 base budgets and projected expenditures for solid waste, Oregon Zoo, MERC, general fund and any special appropriations. In response to council inquiry, Mr. Collier explained that he would be coming back to them to further discuss the Zoo budget and helping the Foundation to become more self-supporting.

Ms. Teri Dresler, Interim Director of the Oregon Zoo, and Ms. Elissa Gertler, Director of Planning and Development, provided brief presentations about budget modification requests for their respective departments and how these aligned with the Metro Council's initiatives and strategic goals.

4. **COUNCIL DIRECTED INITIATIVES**

Ms. Bennett presented an updated version of the Metro Council Initiatives worksheet, which had been previously filled in at the November and December Council Retreats. She explained that the

purpose was to show them what she had heard at the last retreats and to ensure that they were all in agreement between what the Council is owning, paying attention to and just needing to be aware of. Ms. Bennett provided definitions of what each of the categories were:

- Council Ownership: Council is doing most of the work (policy and political) and will be making the decisions on that item
- Council Attention: Items will reflect on the Council, will require some policy work and will
 require significant action on the Council's part (potentially the last decision-maker on these
 items)
- Council Awareness: Other partners are doing the majority of the lifting, but Council does play a role in the decision-making process.

Council reviewed the worksheet, making some minor modifications to items in terms of which category they should be listed under. Council also added the following items to the worksheet: 2018 Regional Transportation Plan policy issues and work plan ideas, Region 1 ACT protocols, My Place in the Region Council outreach, and the Housing Choices work plan.
