WHEREAS, The Executive Officer received three nominations from the North Portland Neighborhood Office; and

WHEREAS, the Executive Officer has authority to appoint members to the Committee for Metro Council confirmation, and

WHEREAS, Upon consultation with Councilor Hansen, Chair of the Committee, the Executive Officer recommends to the Metro Council for confirmation the following names for appointment to the Committee: Laurel Butman, Marsha Everett, and Jana Ripley, now therefore;

BE IT RESOLVED,

1. THAT the Metro Council hereby confirms the appointment of Laurel Butman, Marsha Everett and Jana Ripley to the North Portland Rehabilitation and Enhancement committee.

2. THAT the committee membership and term of service for these individuals shall be from this date through December 1998.

Committee Recommendation: At the December 20 meeting, the Committee voted unanimously to recommend Council adoption of Resolution No. 94-1980. Voting in favor: Councilors Buchanan, Hansen, McFarland, McLain, Monroe and Wyers.

Committee Issues/Discussion: Katie Dowdall, Community Enhancement Coordinator, explained that the purpose of the resolution was to fill three vacancies on the North Portland Rehabilitation and Enhancement Committee. She explained that the proposed appointees were selected after an extensive public recruitment process which included notifying local community and neighborhood groups, local community media, and the inclusion of community representatives on the panel that reviewed and screened the applications that were received.
