I. **WELCOME AND INTRODUCTIONS**

Megan Gibb welcomed attendees and introduced new members Puja Bhutani and Jay Higgins. Committee members and staff introduced themselves and noted their jurisdictional or agency affiliation.

II. **CALL TO ORDER**

Chair Mark Ellsworth called the meeting to order at 10:15 a.m.

III. **APPROVAL OF MEETING MINUTES FOR DECEMBER 11, 2014**

Action Taken: Chair Ellsworth asked if there was a motion to approve the meeting minutes from December 11, 2104. Carlotta Collette made a motion to approve; Jay Higgins seconded the motion. The motion was approved with one abstention.

IV. **ACTION ITEM: APPROVAL OF INTERGOVERNMENTAL AGREEMENT WITH THE CITY OF BEAVERTON FOR THE WESTGATE PROPERTY**

Megan Gibb introduced the action item, sharing the history leading to the development of the new IGA with the City of Beaverton. In 2005, the City of Beaverton approached Metro to partner in purchasing the Westgate property; the TOD Program invested \$2.0 million (44%) in the purchase of the property. For the next few years, Metro worked closely with City staff to attract transit-oriented development on the site but activities halted when real estate markets froze in the great recession. More recently, the City has been exploring development programs that, although laudable, may not be consistent with TOD program goals. The IGA provides for the City to purchase the property at fair market value and thereby take control in negotiating the public-private partnership relationships. Future developers of the site may apply for TOD project funding.

Committee members discussed details of the IGA. They talked about development and transit in the area immediately around the property.

<u>Action Taken:</u> Carlotta Collette made a motion to recommend approval of the Intergovernmental Agreement (IGA) with the City of Beaverton dated March 17, 2015, as presented. Alisa Pyszka seconded the motion. The motion was unanimously <u>approved</u>.

V. **STAFF UPDATES**

Megan Gibb provided an update on work plan changes. Authority to enter into lease agreements was added to the TOD Work Plan. A distinction was made between short term leases, which would come to the steering committee as a briefing, and long term leases, which would come to the steering committee for action.

Jon Williams gave an update on the Southeast 82nd Avenue property. Staff has assembled a developer selection advisory panel consisting of representatives from the Jade District, PCC Southeast Campus, South Tabor Neighborhood Association, Portland Development Commission, the Housing Bureau, and an experienced developer. The first meeting was held March 23 and is working toward issuing a Request for Qualifications within the next 4-5 months. There is an expectation that a developer will be selected soon after and that construction could commence within the next 18-24 months. Until then, APANO has signed a short term lease to occupy and provide community activities in the building. The lease has a twelve month initial term with options for renewals up to an additional 12 months. APANO will pay utilities but will not pay rent.

Committee members discussed the SE 82nd Avenue property and possible issues with short term leases.

Jon Williams provided a budget update.
